



# HOROWHENUA DISTRICT COUNCIL

## SKATEBOARDS BYLAW 2007

This bylaw deals with the use of skateboards within the defined areas of the Horowhenua District as shown within the schedule hereto.

### **PREAMBLE**

Following use of the Special Consultative Procedure as required by the Local Government Act 2002, and in pursuance and exercise of the powers conferred upon it by the Bylaws Act 1910 and the Local Government Act 2002, and their respective amendments, and of every other power and authority in this respect so enabling it the Horowhenua District Council makes and ordains the Bylaw set out hereunder.

### **HOROWHENUA DISTRICT COUNCIL SKATEBOARDS BYLAW 2007**

1. That this bylaw shall be known and referred to as the Horowhenua District Council Skateboards Bylaw 2007.

### **2. Commencement and Revocations**

This bylaw shall come into force on the 6<sup>th</sup> day of September 2007, and as from this date the Horowhenua District Council Skateboards Bylaw 1991 is revoked.

### **3. Interpretation**

In this bylaw unless the context otherwise requires "road" shall be include all streets, footpaths, service lanes, car parks and public places set out in schedules A, B, C and D hereto. "Skateboard" includes any form of mobile platform of less than half a metre square upon which any person stands or rides while it is moving, the motive power being derived from the rider propelling it by means of pushing with the foot against the surface of the ground. This includes scooters whether motorised or not (excluding mobility scooters).

#### **4. Use of Skateboards**

- 4.1 No person shall propel, ride on or use any skateboard on any road, footpath or public place within those parts of the Horowhenua District listed in schedule A, schedule B, schedule C and schedule D hereof.
- 4.2 No person shall organise, hold, conduct or allow any person to compete or participate in any competition or gathering that involves the use of a skateboard within those areas without the written permission of the Chief Executive Officer of the Horowhenua District Council.
- 4.3 Any person authorised in writing by the Council whether an employee of the Council or not upon production of their letter of authority or any Police Officer or Traffic Officer in uniform may impound any skateboard being used in breach of this bylaw. Any such impounded skateboard may be reclaimed from the offices of the District Council upon payment of a fee fixed from time to time by the Council for the purpose of reasonable recovery of the costs of such impounding

#### **ATTESTATION**

The foregoing Bylaw entitled The Horowhenua District Council Skateboard Bylaw 2007 was duly made at an ordinary meeting of the Horowhenua District Council held in the Council Chambers, 126-148 Oxford Street, Levin, on the 4<sup>th</sup> day of April 2007 and following use of the Special Consultative Procedure as required by the Local Government Act 2002 and meantime having been publicly notified, was confirmed at an ordinary meeting of Council held on the 5<sup>th</sup> day of September 2007.
