The proposal is to subdivide a rural allotment (in extent 101.53 Ha) into 15 rural allotments ranging in size from 1.2 to 8.8 Ha, 7 open space allotments (to be held in common ownership) and a local purpose reserve along the southern boundary to vest in the Council to enable pedestrian access to the beach.

The proposal includes an application for land use consent covering earthworks associated with the construction of an internal road and the road itself within an outstanding landscape (Coastal Buffer).
