## Message from the Mayor

### Kia ora koutou

November was a busy month and the new Council hit the ground running. Elected Members recently attended the first of a series

of workshops to get up to speed with Council's key strategic documents and how they inform topics like Three Waters, the Future of the Levin Landfill and Rates Affordability.

We'll soon begin to do the same with our community to help you understand our district's key challenges, the magnitude of decisions required, and how you can have your say.

This year, instead of doing only an Annual Plan, Council proposes to also amend the 2021-2041 Long Term Plan (LTP).

Community feedback is always important to us and the work we do, and we would like you to be more involved in Council's strategic direction and decisions. From now until May next year, you will have the opportunity to participate in the 2021-2041 Long Term Plan Amendment (LTPA) process. We are keen to do things differently and get your feedback - look out for details on how you can be part of our new approach.

With Horowhenua's population forecast to reach more than 60,000 by 2041, preparing for this growth remains a focus for Council over the coming years.

The Ōtaki to North of Levin (Ō2NL) Expressway reached a big milestone in November, bringing a safer and more resilient SH1 route a step closer. Following Ministers' approval, the project team lodged the Notices of Requirement (NoR) and resource consent applications for the new expressway. We are thankful to our iwi partners and Waka Kotahi for their collaborative approach, persistent focus on achieving the right outcome for our local community, and this much-needed investment in national infrastructure. The next 20 years will transform our district and this expressway will be critical to accommodate the growing needs for the future.

Over the last few years the district has been growing fast, meaning our infrastructure is reaching its capacity sooner than anticipated. Renewals and upgrades of network pipes and water treatment plant assets are scheduled, and Council is investigating options to store drinking water to ensure a resilient drinking water solution is in place for Levin and Ōhau.

While we've put significant effort into investigating the options available and have set aside budget within the LTP for the work, we still have a long road ahead before the concept moves to construction. We want to do what's best for the river and our

community and we want you to understand the context and challenges to help us find a solution. Read more about what Council is proposing on page 2.

Some of Horowhenua's most incredible volunteers were recognised with Civic Honours and Certificates of Recognition at the Civic Honours Awards held on 22 November at Te Takeretanga o Kura-hau-pō. One of the highlights in Council's calendar, this year Council awarded 12 Youth Excellence Scholarships Awards, three Certificates of Recognition and five Civic Honours Awards to very worthy recipients. ## Future of the Levin Landfill to be included in Council's Long Term Plan Amendment



### The Future of the Levin Landfill will be included in Horowhenua District Council's Long Term Plan (LTP) 2021-2041 Amendment, ensuring a decision on the future of the Levin Landfill is made by June 2023.

Council were given two options at their 23 November 2022 meeting - to include the decision in the LTP 2021-2041 Amendment or wait until the LTP 2024-2044. There was consensus around the Council table to choose the earlier date, with Elected Members conscious that the timeline would be tight but that a significant amount of time, resource and cost had been allocated over the last five years to reaching a conclusion on the landfill, and a decision was yet to be made.

Additional work is required to complete the supporting documentation for the decision, with future options and the associated financial impact needing to be presented to the community through a formal consultation process. Ahead of formal community consultation, Council will meet a number

of times in the lead-up to Christmas to discuss and assess the Future of the Levin Landfill options.

Mayor Bernie Wanden says, "A decision around a closure date of the landfill is the first step along the way to reimagining the delivery of our solid waste activity. Council is committed to doing the work to ensure that all options are considered for the landfill, alongside a strategic view of waste minimisation for our district, in order for social, cultural, financial and environmental impacts to be fully explored."

Council will consider an additional report on 14 December, where they will make a decision on funding and commitments associated with the remediation of the old dump and current open landfill cell.

## What's Council doing to ensure a resilient drinking water solution?



**Our community has been asking us what we're doing to ensure a resilient drinking water solution is in place for Levin and Ōhau. While Council has put significant effort into investigating the options available and has set aside budget within the Long Term Plan (LTP) for the work, we still have a long road ahead before concept moves to construction.**

We want to do what's best for the river and our community and we want you to understand the context and challenges to help us find a solution.

### Background

The Levin and Ōhau drinking water supply is currently sourced directly from the Ōhau River at an intake site near the existing Water Treatment Plant (WTP) on Gladstone Road, Levin.

Post-treatment storage of approximately 12,000m<sup>3</sup> is provided at the WTP site. This equates to less than 24 hours of supply (less than one day of

current peak demand). The post-treatment storage does not provide sufficient storage to meet extended periods of drought or high turbidity (muddiness) in the river.

Options to increase this are being considered in the short term and will be considered as part of the LTP Amendment.

### So what is Council proposing?

The Water Supply Reservoir project seeks to construct a large scale off-river raw water reservoir to improve the resilience (during heavy rain events and dry weather periods) and reliability of the Levin and Ōhau drinking water supply scheme and to provide sufficient water to meet the projected growth demands for Levin and Ōhau.

Following concept design and a multi-criteria analysis, a single reservoir was selected as the preferred option primarily due to cost considerations and the fact that the embankment required to separate the site into two reservoirs results in a significant loss

of stored volume. The storage volume of a single reservoir is in the order of 700,000m<sup>3</sup>.

### What's been investigated so far?

- Council has completed a feasibility assessment, which confirmed the feasibility of constructing the reservoir site on Poads Road, Levin.
- Council also completed an options assessment, reviewing the available water supply and storage options to ensure the chosen option is the right one. This assessment has been independently peer reviewed.
- Iwi engagement has commenced and will continue through the project delivery, should the project and investment be adopted as part of the LTP Amendment.
- A hydrology assessment is in progress and will continue with technical assessments to support the consenting and design processes. Work to date has confirmed availability of sufficient water in the supplementary allocation framework to support the projected community demand.
- A feasibility assessment saw three intake options assessed. This work identified the preferred intake as a subsurface infiltration gallery in the Ōhau river adjacent to the reservoir site.
- An ecological assessment has been completed of the reservoir site. This confirmed there were no wetland habitats, sensitive environments or threatened or endangered species within the reservoir site.
- An archaeological assessment is in progress.
- Preliminary design is in progress with the design being developed to sufficient detail to support consenting and costings.
- Consents scoping is in progress, but given the scale and complexity of the project, we're working through the options available.



# Foxton Pools is getting an upgrade



**We've got good news for the Foxton community. Foxton Pools is getting an upgrade and construction will start in early February 2023.**

Currently, Foxton Pools is a seasonal facility that can only be used in the warmer months. We're excited that the much needed upgrade will allow the Foxton community to use the pool all year round.

The upgrade will include:

- a rebuild of the building surrounding the pool;
- a new built-in spa pool;
- reception area and
- ventilation systems.

Apollo Projects, an aquatic facility specialist with extensive knowledge of and a solid track record in building quality aquatic facilities, was awarded the contract. They also prioritise giving back to the community and will use local contractors and suppliers in the Foxton Pools project.

Foxton Pools will close the week before construction starts. When it reopens early in 2024 summer season, visitors can expect to see a refreshed fit for purpose facility which still holds the memories of those who have enjoyed it for the past 15 years.

We apologise for any inconvenience during the construction phase.

## Community Engagement

Council engaged with the community on the future of the Foxton Pools in November 2020 as part of the Foxton Pools Feasibility Study. Three options were presented to participants and Council received 676 completed responses that supported building an all-year facility to better meet the community's needs.

Based on the feedback received from the study, as part of the Long Term Plan (LTP) 2021-2041, people were asked to consider five options - an indoor and outdoor leisure pool, a basic all-year pool, a seasonal outdoor leisure pool, a seasonal outdoor basic pool, or permanently closing the facility.

In response, Council agreed to demolish and replace the existing Foxton Pools building to allow year-round use, with no changes to the existing pools.

Aquatic centres are popular places for communities to connect and socialise, through play, sport, fitness, learning and events. Upgrading the Foxton Pools makes physical exercise more accessible. It leads to happier, healthier people and better connected communities.

### History of Foxton Pools

- Established in 1927, Foxton Pools opened as an outdoor pool at Easton Park. It closed in 2007 but was never demolished.
- In December of that year, a new indoor aquatic centre opened at 61-63 Main Street, Foxton. The site housed a 25x10 metre (4 lanes) pool, a 10x5metre teaching pool and a small toddlers' pool.
- Now fifteen years later, the building is in poor condition. High condensation and variable internal temperatures have caused structural decay. Without action, it could become a safety issue.

# Levin & Ōhau water supply to be fluoridated by 31 July 2023

**Horowhenua District Council is one of 14 local authorities that have received a directive from the Director-General of Health under The Health (Fluoridation of Drinking Water) Amendment Act 2021 to start fluoridating its drinking water supply by 31 July 2023.**

The Health (Fluoridation of Drinking Water) Amendment Act 2021 shifted decision-making on fluoridation from local authorities to the Director-General of Health. This change allows for a nationally consistent approach to community water fluoridation based on its well-established health benefits.

The estimated cost of introducing fluoridation for the Levin and Ōhau drinking water supply is \$1M, with ongoing management and monitoring costs of \$40,000 per annum. Council has applied for funding from the Ministry of Health to install the technology needed to add fluoride to Levin and Ōhau's water supply. However, if Council waits for the outcome of its funding application before installation, it will not meet its deadline of 31 July 2023. For planning and procurement to begin immediately, and to ensure Council meets its requirements under the Act, the Horowhenua District Council voted to amend its capital budget at its 23 November meeting to provide for fluoridation of the Levin and Ōhau water supply. Work will commence in early 2023.

Mayor Bernie Wanden said, "The fluoridation of the Levin and Ōhau drinking water supply is an important step in improving the oral health of our community. Ultimately this is a directive of government that we must abide by."

Chief Executive Monique Davidson says, "The direction from the Ministry has come at a time when the sector is facing many changes – some local, some national. Fluoridation is a contentious topic and there will likely be alternative views held by our community. Council is obligated to abide by the directive and it's now time for us to deliver on that directive for our community. The only challenge we now have is ensuring we don't have oral health inequities across our district in the future."

# Donnelly Park netball court set for resurfacing and refencing



**The Donnelly Park, Levin netball courts will be resurfaced earlier than expected, with funding being brought forward to make the courts safer for all users.**

The netball courts were due for renewal work in 2023, but wear brought on by weather conditions and other factors meant the revitalisation is needed earlier than scheduled.

Council has brought forward \$400,000 of renewals funding from 2023/24 to 2022/23 to enable the resurfacing and refencing of the netball courts at Donnelly Park to take place earlier than scheduled after Horowhenua Netball raised concerns that

the current surface had deteriorated and become slippery, posing a health and safety risk to players.

The work is expected to be finished before the April 2023 netball season.

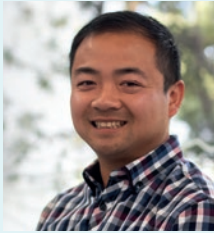
