## **Response - Official Information Request**

I refer to your request for information received on 11/10/2021. Your request has been considered under the Local Government Official Information and Meetings Act 1987 (LGOIMA) and I provide the following information.

 A list of all facilities, as well as administrative & miscellaneous buildings owned or administered by your Council that burn fossil fuels or that are heated by fossil fuels burned offsite (for example, in an energy centre that supplies heat to your facility), with a breakdown for each such facility of fossil fuel type, region, size of heat plant (MW), CO2 emissions, and any Discharge to Air consents held for this activity.

Council facilities utilising fossil fuels (natural gas and diesel) are listed below. Maximum energy output across all sites equates to 2.23 Mw. Council does not monitor its CO2 emissions from these facilities and there are no known Discharge to Air consents required or managed for the facilities concerned.

- a) Civic Building, 126 Oxford Street Levin 1 boiler gas fired, 100 kw;
- b) Levin Aquatic Centre, Levin Domain, Queen Street West, Levin 1 boiler gas fired, 500kw and 1 gas fired infinity boiler 55kw;
- c) Foxton Pool, Main Street, Foxton 2 boilers gas fired 100kw each;
- d) Te Takere (Library and Community Hub), 40 Bath Street, Levin 3 boilers gas fired ,2 x 75kw and 1 x 60kw;
- e) Foxton Coronation Hall, Avenue Road, Foxton 1 boiler diesel, 100kw;
- f) Te Awahou Nieuwe Stroom (Library and Community Hub), 22 Wharf Street, Foxton 2 boilers gas fired, 2 x 100kw;
- g) All sports facilities use gas fired infinities these include
  - Grandstand and changing facilities, Shannon Domain, Ballance Street, Shannon, 2 x 52kw;



- Ablution and Changing Blocks, Playford Park, Bartholomew Road, Levin, 55kw;
- Ablution and Changing Blocks, Donnelly Park, Adkin Avenue, Levin, 8 x 55 kw;
- Ablution and Changing Blocks, Levin Domain, Salisbury Street, Levin 3 x 52kw;
- Ablution and Training Blocks, Easton Park, Johnston Street, Foxton, 2 x 55kw.
- 2. An outline of any plans that your Council or the Energy Efficiency and Conservation Authority have to transition these institutions off fossil fuels, including the names of these institutions, the proposed timing of the transition, and the transition plan.

Council currently has no transition plans or timeframes in place to move away from the use of fossil fuels described above, and has employed no organisation or authority to develop such plans.
