### Response - Official Information Request

I refer to your request for information received on 21/06/2021. Your request has been considered under the Local Government Official Information and Meetings Act 1987 (LGOIMA) and I provide the following information.

May I please have updates on the following projects? I was unable to find these mentioned in the draft Long Term Plan 21-31

#### Project Name - JUBLIEE PARK

Description: Council to undertake site planning, analysis, feasibility study and stakeholder engagement in 2020/21 FY, for the development of a splash pad at Donald Duck Park in Jubilee Park. Project construction then expected to be included in next Long Term Plan (LTP)

Specification: Remove paddling pool and build new splash pad

Cost: \$450,000

A budget of \$310,000 for the construction of a splash pad at Jubilee Park has been included in the 2021-41 Long Term Plan that was adopted on 30 June 2021.

#### Project Name - LAKE HOROWHENUA STORMWATER QUALITY IMPROVEMENTS 2021/22

Description: Funding was allocated in 2021/22 FY of the 2018-28 Long Term Plan (LTP) for Lake Horowhenua stormwater quality improvement project.

Specification

Cost: \$547,000

For this one there is also mention in the last LTP for 2021/22 \$547K will this also be completed this FY or will it be deferred?

The Long Term Plan 2021-41 was adopted on 30 June 2021. There is a budget of \$343,000 for the Lake Horowhenua water quality improvement project, which at this stage is mainly for getting a resource consent.
