2. Recommendation

3. Issues for Consideration

3.1 Representation Review

The recent decision made by Council to establish a Māori Ward has triggered a requirement for a representation review process to be undertaken this year.

This review will enable decisions to be made on representation arrangements for the 2022 Local Government election including the number of elected members, names and boundaries of constituencies, number of representatives in each constituency, Community Boards and how Māori Wards and General Ward Candidates will be elected.

Following the adoption of the initial proposal by Council, there will be an opportunity for public consultation through a submission process.

3.2 Foxton War Memorial Hall Update

Attached to this report is an update memo from the Foxton War Memorial Hall Interim Committee.

3.3 Foxton Beach Progressive Association - Chairperson's Report

Please note there is no report from the FBPA due to the timing of their meeting with key stakeholders falling on 27 June 2021.

3.4 Project Updates

The updates below relating to Foxton and Foxton Beach are information duplicated from the Infrastructure Development Activity Update report from the (cancelled) 26 May 2021, Finance, Audit & Risk Committee meeting.

Infrastructure Development Activity Update

Foxton River Loop Regeneration - Stage One

Progress update

During April the reserve was lightly harrowed, levelled and under-sowed. This has resulted in an improved grassed surface. The playground is starting to take shape and the fort structure is nearly complete.

Work has continued on the new access and carpark near the Foxton River Loop Hall (Red Shed). A concrete pathway linking the reserve through to the carpark has been boxed out this week and is ready to be poured. This will future proof the area if there is a need to extend the path north of the reserve. Soft landscaping will be completed around the carpark to tidy the space.



The Harbour Street roading work and the pathway to Paretao began during May. The plan is for the pathway to finish at the boat ramp on Harbour Street and be incorporated into an upgraded Harbour/Union/Main street intersection.

Financials

April was a relatively quiet month on site with approximately \$280K of work performed. The focus has been on procuring the roading contracts and installing park amenities. Bad weather hampered productivity somewhat.

Costs are expected to ramp up next month due to roading works that have just gotten underway. By the end of June the actuals will close in on the budgeted expenditure, apart from the long lead park amenities which are not available for installation until end of August 2021.

Work remains on track for substantial completion by the end of June 2021.

Focus for next month

Activity on Harbour Street will increase over the next month with planned roading improvement and pathway work commencing.

Final playground elements will be installed, once this area is completed the contractor will do soft landscaping to tidy up the area and plant the remaining trees. The lawns will also be mowed properly for the first time.

The handrail from the Whirokino Bridge will be installed along with feature LED lights and a plaque explaining the history of the Bridge.

Foxton Waste Water Treatment Plant – Stage Two – Pond Construction

Progress update

Excellent progress last month. During April all pond site stripping was completed and the geogrid was installed. Construction of the southern and south western bund commenced with the inlet and outlet pipe work installed. Construction of the subsoil drains to the west and north have continued.

Throughout May Council continued to construct the pond bunds, moving up in layers and supervised by our specialist geotechnical engineers.

All HDPE gas liner and pond liner materials are now on site. The installation crew will mobilise on 17 May and commence installation – weather dependent.

The project remains on track for completion by 30 June.

Financials

Bulk earth works were completed in April with a small amount continuing into May. This leaves the construction of bunds and gas liner/liner install to be the large items to be completed in May.

The team's excellent progress and high productivity has meant that tracking is under budget for the month ended April 2021. It is forecasted that the project will be completed within budget.

Focus for next month

The bund construction and subsoils will continue until completion in May. The HDPE liner crew anticipate to finish in May / early June.



Risk and Mitigation

The HDPE liner cannot be laid in high winds or rain. The forecast includes contingency for time delays.

Foxton Beach Wharf Shared Path and Wharf Maintenance

Progress update

The maintenance of the Foxton Beach Wharf got underway in early May. Over the next month Council will place 800 tonnes of rock to shore up the foreshore area. Council will also extend the existing Manawatū Estuary Shared Pathway to connect to the Wharf.

Materials and plant have been mobilised to site and a safe working area created with temporary fencing. Survey set out has been undertaken marking the crest of the revetment wall, site clearance has commenced removing the damaged gabions and debris.

Financials

Works have only just got underway. There are no actuals to report. Financial tracking will be provided at the next FAR Committee meeting.

Focus for next month

Site clearing will continue and material will be imported where required to bring up the subgrade for the revenant wall. Once the subgrade is brought up to the correct level geofabric will be laid and the rock will be layered on top.

Works on reinstating the eroded car-parking area, landscaping and construction of the new pathway will commence in June.

Risk and Mitigation

Tides and bad weather present the highest risk to delivery. Council has made contingency allowances in its construction programme and financial forecast.

SUBJECT: Revitalisation of the Foxton War Memorial Hall

The interim committee for the FWMH wishes to thank the FCB for their support resulting in a positive but complex action plan to move the hall back to local residents' control. This report is the first of many to come as we wish to keep the FCB fully informed of our progress.

Having visited the Hall to gain a perspective of the external and internal conditions of the Foxton War Memorial Hall members of the FWMHIC met last night to review HDC's criteria for taking over ownership and responsibility for operating the Hall on behalf of our community.

Having considered all of the Council's criteria FWMHIC is committed in good faith to do its best to proceed as quickly as possible with turning the hall into a viable operation for and on behalf of our community. However, there are a number of criteria we feel which require further clarification before we can start to make substantive progress. In the circumstances FWMHIC will be seeking a meeting in short order with HDC's CEO, David Clapperton and our two Councillors, Ross Brannigan and David Allan so that once this has been done we can make further progress in revitalising our Hall.

Once we are clear about the exact criteria under which we are expected to operate we will be organising our first community meeting to get support for our proposed Constitution and election of officers to our Incorporated Society.

Report to Foxton Community Board – from Tricia Metcalf as FCB Rep

Mavtech

Manawatu Estuary Trust (MET)

Date: 28th June 2021

Group Highlights of Activities MAVTech Acting Chair's Comment He noted that MAVtech is at a critical point in its planned redevelopment Highlights from programme and that there have been a number of setbacks in the past 15 May meeting year; including 3 failed funding applications; cancelled Trust meetings and the general impacts of Lockdown. Submission to LTP MAVtech made a submission to Horowhenua District Council for inclusion of a proposed strategic "partnership" in the Council's Long Term Plan - LTP -(ie: HDC:MAVtech) and presented to Councillors on Thursday 13 May. Key points made are that to be credible to outside funders and sector agencies, MAVtech needs the publicly proclaimed support of the Council, and in due course some co-funding of redevelopment, and ongoing HDC ownership of the building, Also noted that HDC can offset all maintenance and ongoing costs related to the Hall and MAVtech as substantive cofunding contributions. Detlef thanked Frank Stark for the substantial work contribute in the preparation of the submission, as well as his attendance at the LTP hearing on 13 May. The processes and criteria for funding have become much more complex in recent years and such applications now require much time and expertise in preparation. For example just the time spent on the last one totalled probably 70 hours...apart from more hours of work by other MAVtech members. All the above highlight the need now for a Trust Board which has: greater Museum sector expertise; members with connections and profiles to the sector and central/local government; and individuals who can commit to working on specific projects and initiatives. Finally Detlef noted the effective support forthcoming from Trustees and Team members and in particular thanked contractors Toni Edmeades and Frank Stark for their voluntary contributions of time and effort – which has meant they have contributed well beyond the activities and services for which they are contracted. Funding applications Funding of \$25k has been sought from Te Papa's Hardship Grant Fund. If successful, funding received will be applied to further documenting the collection and for enhanced support services for MAVtech. An application for finding has been submitted to Foxton Promotions Group for new Radio Foxton equipment. (We are pleased to say this grant application was

successful)



MET

Meeting Highlights from June meeting

1. Viewing Platform

Kath emailed the DOC Operations Manager, Moana Smith-Dunlop, and received a reply via Abi Wightman, requesting the following:

- a Written agreement shall be drawn up between MET and DOC once it is clear who is constructing or maintaining the structure, and removing it if it can't be maintained
- all local council regulations must be adhered to when applying for permission to construct as with any other structure
- there is clear written evidence that the local residents in Hartley St have been consulted and are supportive of the idea.

Kath has a picture and draft plan of the proposed viewing platform to go with a letter to be hand delivered to the nearest residences to the site. Responses can be posted but there needs to be a deadline. It was suggested that we provide DOC with what we are going to give to the neighbours to ensure it meets their approval. Bob Hoskins suggested we download from HDC a map showing the properties that we would contact. Terry Oliver Ward will add the details to that.

Sean Hester said we would most likely be required to canvass neighbours for a Resource Consent anyway so we should go ahead as soon as we can.

2. Sean Hester (HDC).

HDC is putting in an application, with Foxton Beach Progressive Association, for \$70,000 over 3 years (\$30K, 20K and 20K) from Horizon's contestable Biodiversity Funding, for work on the Foxton Beach dunes from the Ramsar site north.

HDC will also contribute to the work which will include pest plant removal and planting of spinifex and Pingao of the fore dunes, and scrubland plantings for the top and rear dunes.

Sean requested that MET write a letter of support to accompany the application. In answer to a question he explained that the work does not include any of the Ramsar site as there is a separate funding approach for that by Horizons.

3. Fencing Dune Wetland and Dunes:

Bob Hoskins has written a submission for the Horizons' Biodiversity Funding, for fencing the area where Arnim Littek and his team have been removing unwanted plants and maintaining it.

Unfortunately Sean Hester said HDC would be unable to support it because of the safety factor of the wire fence. HDC would be responsible for any accidents.



WFT – Wildlife Foxton Trust - Liaison Report to Foxton Community Board

Ngaire Newland 28 June 2021

- Thanks to private donations, Wildlife Foxton Trust are about to start the first stage of their exhibition centre, with the arrival of a 40ft container that will be fitted out with aquaria of approx.
 6 large tanks.
- WFT have unfortunately to date been unsuccessful with jobs for nature applications, but the native plant nursery is helping them to continue to grow.
- The WFT monthly newsletter was distributed on 10 June includes:
 - Due to the effort of amazing volunteers, we have started work on our outdoor lizard enclosures. What's particularly important to us, is that each species has an authentic natural environment suited to their needs
 - There have been some busy bees altering the heights of gecko enclosures so children can more easily view the animals. The insides have also been revamped
 - We have been planting stinging nettles to attract native admiral butterflies whose caterpillars feed on the leaves, and we have had success already. Red admirals/kahukura are endemic to NZ so it's great to help their population and encourage them into our gardens



Foxton Tourist and Development Board Report

After the Foxton Community Board appointed me as their representative on the Foxton Tourist and Development Association [FDTA], I waited for information regarding the next meeting.

As I heard nothing, I mentioned it to David Roache who is the Chair of the FTDA as well as Chair of FCB. Within two weeks I received an email from the 'Management Committee' of FTDA.

The email thanked me for 'volunteering' to be the Community Board Representative, but that as David Roache was Chair and Past Patron of FTDA they wished him to be their liaison with the Foxton Community Board. They thanked me again for volunteering and advised they would contact me if they found a role for me.

I thanked them for their email and said that I looked forward to attending their next meeting when I could apprise myself of their 'modus operandi' and see how I could make a positive contribution.

There has been no response from them and I do not know if they have even had a meeting recently.

It would appear that they are not aware that I was appointed by the Foxton Community Board to be the Community Board Representative on FTDA, not the other way round.

As current Chair of the Foxton Flax Stripper Museum and the Foxton Districts Budget Service and former Chair of the Wildlife Foxton Trust and the Foxton Horse Drawn Tram Society, as well as being a member of the Foxton Futures Governance Group, and Save Our River Trust and an office holder in Te Awahou Lodge 133, I have a wide experience and interest in the Foxton and Foxton Beach communities and their future.

I would appreciate a discussion and further direction from the Foxton Community Board regarding this matter.

Localism – does it have a future?

As a general rule, countries that are centralised tend to be less wealthy and have lower standards of living than countries which are decentralised.

 Localist approaches to governing incentivise more proactive approaches to economic and social development opportunities



 Centralised governments tend to be paternalist - encourages the assumption that the government will fix things

With central government responsible for approximately 90 per cent of all public expenditure New Zealand stands as one of the most fiscally centralised countries in the OECD, see table 1:

LGNZ's localism programme is designed to address New Zealand's high level of fiscal centralisation and the problems that stem from our comparatively week local governments.

We are seeking:

- The right of councils to govern and administer their responsibilities within a clear and stable set of rules and without arbitrary intervention from central government;
- A transfer of political functions and responsibilities from central to local government accompanied by an authority for councils to set levels of services appropriate to the needs of communities;
- A fiscal re- balancing so that taxes and other forms of public revenue are allocated commensurate to the revenue needs of each sphere of government.



Local government reform

Overall purpose

- 're-imagine the role and function of local government', in order to build a sustainable system that delivers enhanced wellbeing outcomes for our communities.
- to identify how our system of local democracy and governance needs to evolve over the next 30 years
- to improve the wellbeing of New Zealand communities and the environment,
- and actively embody the Treaty partnership.

The Foxton Community Board (the Board) thanks Palmerston North City Council and the members of the Nature Calls project team for their presentation on the 19th April 2021. The Board appreciated the opportunity for an update on the project and the current work as well as the assessment and technical review process to determine the best practicable options.

As representatives of the community of Foxton, the Boards' preferred option for treating and discharging of Palmerston North's wastewater is 100% discharge to land.

However, bearing in mind the prohibitive amount of land required for this option and its cost, we understand, there must be some discharge to the Manawatū River. This treated wastewater must be of a potable standard.

The Board is concerned that with the hybrid system, as in option 2, with the wastewater being treated "not as high as in option 1", this would not be suitable or acceptable for discharge into the river.

All wastewater discharged into the Manawatū River must be treated to a potable standard. This applies to any option.

The Boards' Weighting of Values as provided in the Consultation Feedback form are outlined below:

- 1. Natural Environmental (ecology)
- 2. Social and Community Values
- 3. Maori Cultural Values
- 4. Public Health
- 5. Innovation and future proofing technology
- 6. Growth and Economic Development
- 7. Financial (cost of option)
- 8. Resilience and Climate Change Impacts (future)

The Board understand this is a feedback process and not a formal submission process, but wish to express their interest in presenting to the Palmerston North City Council during the formal process once the consent has been lodged.

We look forward to being kept informed and being part of further discussions.
