1. Purpose

To receive submissions in relation to the Future of the Levin Landfill Statement of Proposal and to hear from submitters.

2. Recommendation

That Council:

- 2.1 RECEIVES the Report 22/45 Hearing of Submitters - Future of Levin Landfill.
- 2.2 RECEIVES submissions 1 - 149 on the Future of the Levin Landfill that were lodged with the consultation time frame
- 2.3 RECEIVES submission 150 in accordance with the Council's Acceptance of Late Submissions Policy.

3. Background/Previous Council Decisions

The Future of the Levin Landfill consultation ran through from 31 November 2021 closing 5pm 31 January 2022. During this process five drop in sessions were held for the community to ask question with subject matter experts. These were held in Foxton, Levin and Hokio Beach. In addition social media was used to provide further information through videos and a livestream, posters were displayed throughout the district, newspaper articles, and officers were available to answer any questions that may have arose during that period. A total of 150 submissions were received and 25 people wish to be heard at the hearings.

4. Issues for Consideration

Councillors are provided the opportunity to consider submissions before reaching final decision. Twenty five of 150 submitters have requested to be heard in person. The schedule of submitters to be heard is found at appendix 1.

A copy of submissions are provided under a separate cover to this report.

Future of the Levin Landfill

Your Submission

As set out in this Statement of Proposal the Council is considering options for the future of the Levin Landfill and before it makes a decision it wants to know your views. It is important to note that whichever option is decided the Council will continue to offer the current kerbside collection service and continue to aim to maximise recycling.

No matter how extensive the Council's waste reduction and recycling activities are there is an ongoing need for environmentally responsible residual waste disposal. The reasonably practical options considered are:

Option 1

Close the Levin Landfill in 2022

Council-controlled waste would be transported to an out of district landfill based on a disposal contract. The contract would need to state that the out of district landfill must continue to meet its environmental requirements. The Levin Landfill would be closed and capped. The site would continue to be monitored and managed for many years to ensure any ongoing environmental effects of both old and modern landfills were dealt with.

Option 2

Close the Levin Landfill in 2025

Between 2022 and 2025, operations would continue at the Levin Landfill. The Landfill would continue to accept a mixture of Council's waste and other waste. The Landfill would be closed by the end of 2025. After this date Council's waste would be transported to an out of district disposal location on the same basis as Option 1 and Council would continue to monitor and manage the Levin Landfill site.

Option 3

Close the Levin Landfill in 2037, or sooner if full

Operations would continue at the Levin Landfill until expiry of its consent to operate in 2037. The Landfill would be closed earlier if it reached its consented capacity before 2037. The Landfill would continue to accept a mixture of Council's waste and other waste.

Monitoring and management of effects during operation and after closure would occur to ensure it operated within its consents.

April 1998. An appeal to the Environment Court⁴ was lodged by Eugene Henare, Peter Everton and Ivan Jones.

24th May 2002 or thereabouts, when it finally got to Court, the Horowhenua District Council tried to take me for costs of \$54,000.00. The Judge threw that out, so that was mud on the face of HDE.

After that case the Levin Landfill "Neighbourhood Liaison Group" the (NLG) was created.

The parties to the NLG created at that time, is the Horizons Regional Council (The Police), Horowhenua District Council, and Landfill objectors Peter Everton, Eugene Henare, Ivon Jones, the Grangers, Charles Rudd and Vivienne Tauaki.

Note: Any additional members to the NLG has to be in agreement of the three parties involved, of which Malcolm Hadlum, Dave and Pataka Moore became involved.

Specific Conditions – Neighbourhood Liaison Group (hereinafter “NLG”)

32. The Permit Holder shall establish an NLG. Members of the NLG will suggest available and suitably qualified nominees for an independent facilitator in advance of or at the first meeting. The list of nominees must be limited to six nominees. The Permit Holder will confirm that the list of nominees contains suitably qualified people for the facilitator role. The NLG will appoint an independent facilitator from the list of nominees confirmed by the permit holder at that same meeting. In the event consensus cannot be reached an independent facilitator will be appointed from the list of nominees by a majority vote of community NLG representatives as identified in (a) to (d) and (g). ~~administer and manage a NLG and appoint an experienced and independent facilitator for the purpose of chairing the NLG. The facilitator shall be jointly agreed to by the Permit Holder and the Regional Council's Regulatory Manager.~~

At the invitation of the Permit Holder and/or NLG, other parties may attend NLG meetings as jointly agreed by both the Permit Holder and NLG.

The representatives on the NLG are responsible for reporting back to their members and interested parties. The ~~p~~Permit ~~h~~Holder will make (unless confidential) the reports and information provided to the NLG and the minutes of the NLG available on its website.

* The ~~p~~Permit ~~h~~Holder is responsible solely for the reasonable costs of administering the NLG, such as providing a venue, the facilitator's costs and drafting up of minutes.

The facilitator will be paid in accordance with level 2 of the fees range for members under Cabinet Office circular (12) 6: "Fees framework for members appointed to bodies in which the Crown has an interest".

33. The Permit Holder shall:
- a. Convene one meeting by the end of June 2019 to appoint an independent facilitator in accordance with clause 32 ~~six months after the the 2015 review decision is final.~~

 - i. Able to advise the Permit Holder of potential members of the NLG, such new members to be at the agreement of the Permit Holder.

The Permit Holder and the Landfill Operator shall not unreasonably withhold such agreement. The Permit Holder shall grant the NLG members access to the landfill property, during working hours, subject to relevant regulations, including health and safety regulations and the Management Plan.
 - iii. Consulted by the Permit Holder as a group prior to any change of conditions pursuant to section 127 of the Resource Management Act 1991 (and/or any consequential amendments).
 - iv. Provided by the Permit Holder with a copy of all monitoring reports and other documentation relating to the non-commercially sensitive, environmental operation of the landfill, at the same time as such reports are provided to the Regional Council in accordance with the resource consents.
 - v. Able to raise with the Permit Holder, as necessary, any matter which the NLG member believes the Permit Holder should address in order to meet the conditions of the consent(s).

My Submission on preferred options on closing the Levin Landfill is Option 1 – Close the Levin Landfill in 2022.

Our company farms land on the south, east and west of the landfill property in Hokio Beach Road Levin. I have been involved with the landfill since the mid 1970's after the closing of The Avenue dump site north of Levin.

I attended meetings called by the Horowhenua District Council at Kawiu Marae in 1994 and 1995. They wanted to extend their rubbish dump in Hokio Beach Road into a regional landfill and close their dumps at Foxton, Foxton Beach, Tokomaru, Shannon and Manakau. The consensus of those meetings was that the people did not want a landfill at Hokio, the site in the sand hills was not suitable and a landfill in this area would be culturally insensitive to the local Iwis. After these meetings I attended all the mediation hearings at the Levin District Council office in Bath Street. The Council Engineer Greg Boyle, the Council's Lawyer Andrew Cameron, the Mayor Tom Robinson, the Deputy Mayor Brendon Duffy all assured us that it would be a revenue stream for the Horowhenua District Council and help subsidise rates for the districts ratepayers. At the mediation hearings with the objectors to the new landfill extension, the Council lawyer Andrew Cameron said the Council would sue for costs if the objectors were to take a case against HDC in the Environment Court and lose. A large number of the objectors withdrew from the mediation hearings because they felt they could not afford to be sued, leaving three objectors to take a case against Council to the Environment Court.

The three remaining objectors main concern at the time was the dumping of liquid waste into the first dump site (established in approximately the mid 1970's) behind Grange's property. Council dug large holes in the first old dump site and septic tank trucks from the district discharged their waste into these holes. The objectors required that HDC stop this dumping of liquid waste immediately. (The Grange's property was subsequently purchased by Council just a few years ago.)

After approximately two years discussion between the parties (i.e. the objectors and Council's lawyer and engineer), the Environment Court allowed the landfill to go ahead with conditions under the Resource Management Act. These conditions were signed off by Judge JES Allin on 24 May 2002. Horizons were set up by the Environment Court to be the watchdog to ensure that HDC met all their resource consent conditions. Both Councils have failed the Hokio people and the ratepayers of the district with continuing breaches of the resource consents. In 2008 there was an Environmental Management Review of the landfill culminating in a report in August 2008 by Dr Jan Wright, Commissioner of the Parliamentary Commission for the Environment. She was critical of both HDC and Horizons regarding the management of the landfill. She said "There has been a history of resource consent condition breaches on this site, some of which have been recurring." Her report found inadequate monitoring resulted in pollution in the Hokio area including storm water drains and streams.

In those years to 2008 HDC and Horizons ignored the Neighbourhood Liaison Group (NLG) – of which I am an original member. The setting up of the NLG was one of the requirements of the resource consents as a way of communicating and helping the HDC meet their consent conditions. Council continues to ignore the NLG.

After nearly twenty years of litigation on the landfill, the NLG members do not want to see another fifteen years of litigation.

Any Councillor who may receive a financial benefit from keeping the landfill open to 2037 should not be able to vote at any meeting regarding the Levin landfill.

Attached is a list of landfill non-compliance by HDC.

Peter Everton

- HDC is non-compliant - a meteorological weather station¹⁶ required since November 2016 has never been set up to collect daily weather data.
- HDC is non-compliant - HDC management has prevented an NLG member from verifying data collection on the grounds of health and safety¹⁷
- HDC is non-compliant: cover at the end of the day¹⁸ to keep odours down frequently not done. Rubbish poking through the cover
- HDC is non-compliant: gulls and scavengers were feeding at the tip site¹⁹
- HDC's lawyers prevented Neighbourhood Liaison Group members from "adding new conditions as necessary" because HDC had that clause deleted, without agreement of the NLG.
- The Project Management Group must maintain HDC's confidences and not share them with interested groups or the public.
- Quarterly reporting monitoring (Permit 6010, Condition 2Q) consistently doesn't occur quarterly.²⁰ While the sampling is supposed to be January, April, July and October, 2 of the past 3 years reports have been conducted in consecutive months or 5 or 6 months apart.²¹
- Inaccurate and unreliable quarterly reporting¹⁸ where the same values are recorded in consecutive reports: July and September 2019, and May and June 2020.
- Non-compliant: monthly sampling of Hokio Stream, Tatana Drain not undertaken due to miscommunication between HDC and the monitoring contractor²²
- Non-compliant: the intermediate cover laid over the landfill should be sand and mulched wood, not sand alone.
- One of two old landfill sites which was the main recipient for sewage sludge remains uncapped.²³
- HDC requires NLG members to ask for secret reports that members know nothing about because they're not told of their existence. "Copies of this LMP shall also be made available to the members of the Neighbourhood Liaison Group (NLG), on request." ²⁴
- Forget that the intermediate cover should be sand and mulched wood and doesn't so it is non-compliant
- Forget that the Wairarapa soil has never been scientifically tested but by hearsay is accepted and that it's okay to be dumped at the Hokio landfill when it bypassed 3 closer landfills

The best ranked financial outcome is presented by Option 1, close the Levin Landfill in 2022 and elected members must decide that is the best option proposed.

Kia ora,

My wife and I have had a property at Hōkio Beach for the last 15 years. This has primarily been used as a holiday home, but in 2015 we returned from an overseas work assignment and moved permanently there for an extended period of time. It was at this time I came to more fully understand the issues with the environment in & the governance of the Horowhenua region, and more specifically for this submission with the situation regarding the Levin Landfill.

It is for many, many reasons I support Option 1 – Closure of the Levin Landfill in 2022.

Summarised as:

- at the most basic issue, the landfill itself is poorly situated in a beach environment, near waterways and the ocean - similarly the District Council has also chosen to locate it's sewerage facility on the shores

of Lake Horowhenua, at best these placements could be seen as unwise but at worst be seen as a total lack of regard to welfare of both the local environment and community (Iwi).

- the landfill has been poorly managed by the consent holder for its entire existence, evidenced by poor record keeping, practices and ongoing inability to operationally meet resource consents. The high ongoing costs of reviews, lack of proper accounting (transparency) for the costs of the landfill operation and the “late” (failed) efforts to try and achieve compliance (it wasn’t with surprise that this poor management was highlighted again by a latent realisation in late 2021 that the current cell was now at capacity).

- the relationship between the District Council and Regional Council (as Consent Holder and Consent Enforcer), must be questioned – for a landfill to have been so non-compliant yet for the communities concerns and reports of non-compliance over decades to have been so callously ignored / not acted upon just beggars belief. It has only been in very recent times that the Regional Council appears to have actually started to enforce the consents (kind of), rather than what has appeared for a long time to collude with the consent holder to make the problem go away i.e. ignore it.

- it was with great relief that I read the report from Morrison Solutions, this was a huge surprise as I had been involved with the earlier Social Impact Report commissioned by the District Council (written by Bronwyn Kerr). The initial report was a similarly strong document regards the situation of the Social Impact and the relationship with the District Council and the local community (Iwi), however the final published report had been significantly “watered

down” (lack of independence) – this had been very disappointing at the time, but had reflected outcomes from other processes of the District Council. The Morrison Solution’s report categorically supports Option 1 – Closure in 2022. It has always made sense to the local community (Iwi) that the longer the landfill is operational the more damage will be caused.

- looking at P9 of the The future of the Levin Landfill – Te Anamata o te Ruapara o Taitoko – Statement of Proposal, it is hard to imagine beyond self interest how a Councillor could vote for any other option other than Option 1. Personally I applaud the 7 Councillors who have shown true leadership for voting for this Option back in late 2021.

- in particular I am very concerned if Option 1 is not confirmed that there is significant risk of ongoing litigation, Environment Court action, and continued environment and social damage. There are many unknowns in the financial risk aspect to this landfill beyond just the on-going cost of reviews, litigation etc. At this stage running an inefficient non-compliant landfill (e.g. poor rates of gas capture, non-compliant activity etc.) means the District Council is exposing its rate payers to significant risk of fines, significant & increasing costs of Carbon Emissions etc.

- personally I have experienced the gaseous odour from the landfill on our property in the Hōkio Beach township (and have made several formal complaints over the years with limited success i.e. any follow-up from the Regional or District Councils). I have also witnessed a degradation of bore water in the Hōkio Beach township, back in 2007 our neighbours bore water was clear and used for washing and watering gardens etc., by mid-2010’s the bore water was coloured (brown) and stank – to the extent that our neighbour stopped using it entirely.

• my wife and I met and befriended Erl and Gwyn Grange, at the time owners of the property adjacent to the landfill, which was subsequently purchased by the District Council. At that time, I had been at the property where I both experienced strong odour (inside their house – smell evident in the curtains etc.), and evidence of ground pollution (oil in the water in their paddocks on the landfill boundary). We also heard emotional accounts of the impact the years of pollution (particularly) had on them and their whānau – this was a shocking situation, one despite eventually buying them out, that the District Council should be ashamed of.

• we've just had an extended break at the beach over summer, we have spent much time swimming in the ocean and spending time generally at the beach enjoying the incredible lifestyle that the Horowhenua region can offer. As an indicator of the lack of care for the environment I did find it frustrating that the Regional Council has chosen to remove Hōkio Beach from their monitored swim spots – in 2017 Hōkio Beach was red-zoned, between 2018 and 2020 the number of sites monitored dropped from 42 to 25, incredibly somewhere post-2017 the previously red-zoned Hōkio Beach has disappeared from the Regional Councils gaze.

I vote "Option 1 – Closure in 2022".

Comments:

The Levin Landfill has been problematic ever since it was established (as a temporary solution). As Professor Alexander Gillespie points out " The cheapest manner to dispose of waste has always been at locations close to poorer communities" Hokio is one such community, which has born the negative impacts of this landfill for generations. Unfortunately concerns raised about this landfill, it's devastating environmental and cultural impacts have continuously fallen on deaf ears.

The Parliamentary Commissioner for the Environment has been highly critical of the Horowhenua District Council and Horizons the Regional Council for their management and enforcement of resource consents for the Landfill.

A tension exists in HDC which both earns revenue from waste disposal at the landfill, while also being required to meet national expectations of waste reduction. The proposed new national waste strategy for Aotearoa New Zealand will further increase expectations of HDC to take responsibility for the past, present and future condition of our natural environment. To regenerate natural systems that have been badly affected by the Levin Landfill, so the environment is healthy for future generations. And to deliver equitable and inclusive outcomes for the community in which this landfill currently operates.

HDC has cared less about the community in which the landfill is located. It has exploited a poor community to profit the few, trashing the environment for short term gains. Their behaviour runs counter to the

actions a responsible Council. One that understands the economics of a healthy environment and that endeavours to create a desirable, unspoiled and appealing region in order to attract new rate paying citizens.

The ongoing financial, cultural and environmental issues of the landfill are not occurring in isolation, the negative impacts flow into other related systems. Closing the landfill in 2022 will enable Horowhenua to meet the outcomes of Te Mana o Te Wai - "Making immediate improvements so water quality improves within five years and reversing past damage to bring our waterways and ecosystems to a healthy state within a generation." (1)

HDC's own (undated) Statement of Proposal shows Option 1: Close the Levin Landfill in 2022 as the best-ranked outcome with the best alignment to the WMMP, highest wellbeing score and lowest cost or risk.

We must act now, not only to meet our national Climate Change Targets but also our global commitments. The Levin Landfill is 70% inefficient at collecting and destroying methane. While the Statement of Proposal presents the Current Emissions Trading Scheme cost of \$54/tonne of waste. It does not account for the social cost of carbon, a cumulative economic impact of global warming caused by each tonne of carbon sent out into the atmosphere. Research has found the global median of more than NZD \$550 in social costs per tonne of CO₂ (2).

The cost of inaction or delayed action will further negatively impact on the local environment, emission trajectories, socio-economic development and climate-driven economic damage. HDC can no longer

Tēnā koe Mayor Wanden,

Thank you for the opportunity to make a submission through the Special Consultative Process Council has initiated to determine the future of the Levin landfill.

The Project Management Group was formed to address the issues associated with the performance and future operation of the Levin landfill. It is a multi-stakeholder exercise delivering positive results outside of the previously litigious and frustrating statutory processes that had been so much a part of the operation of the Levin landfill.

The primary focus of the Project Management Group (in which the Council, community and Regional Council have an active role) is to deliver outcomes including landfill closure, site restoration, monitoring, review, community support, and restorative justice.

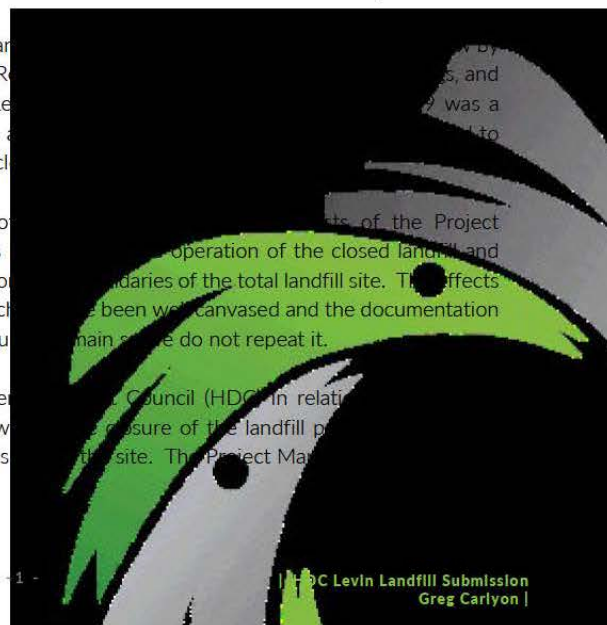
The Levin landfill site has been operated in a way that exacerbates 50 years of degradation within the Hōkio rohe with impacts on the whenua, awa, hapū, adjacent landowners, and local community. Many of the effects generated by the landfill have been serious in nature and a number of them continue to this day.

The landfill has been subject to multiple assessments and reports by the Parliamentary Commissioner, two reviews by the Resource Management Act, and many compliance actions over a long period. The Levin Landfill is a landmark statement from the Council and community and a key part of the Council's most recent decision to recommend landfill closure.

While the Councillors are recommending closure of the Levin landfill, the Project Management Group have always been broader. This submission is a requirement to address significant adverse effects beyond the boundaries of the total landfill site. The effects of the operation of the landfill including odour and leachate have been well canvassed and the documentation in relation to these matters is readily available in the public domain so we do not repeat it.

We strongly support the position taken by Horowhenua District Council (HDCC) in relation to the closure of the landfill. In particular, we acknowledge the decision in order to address a number of outstanding issues at the site. The Project Management Group has been working with your team on these matters.

The key reasons for early closure of the landfill are well described in documents before the community. For the record the Project Management Group supports **Option 1** alongside the Council for the following reasons.

- The benefits of immediate closure are significant for iwi, hapū, and the stakeholder community.
- The cultural impacts of immediate closure are lowest.
- The environmental impacts of immediate closure are lowest.
- The economic benefits for immediate closure are highest for Option 1.
- The determination to adopt Option 1 is consistent with Council's waste management strategy and national directions for the management of solid waste.
- The adoption of Option 1 has a significantly greater benefit for greenhouse gas emissions.

We also note that there are significant risks associated with the ongoing operation of the Levin landfill beyond 2022. The Council has been unable to identify how any option for closure beyond 2022 would mitigate risks in a way that impacts would not be serious for the environment, community, and economy.

We note Council's view that odour and leachate losses from the landfill site are not or will not be significant in the future. In our view this position cannot be supported, particularly in the context of significant initiatives focused on cleaning up awa and the need to address the landfill on a holistic basis. The Project Management Group looks forward to working through these issues on a constructive basis with stakeholders over these next few months.

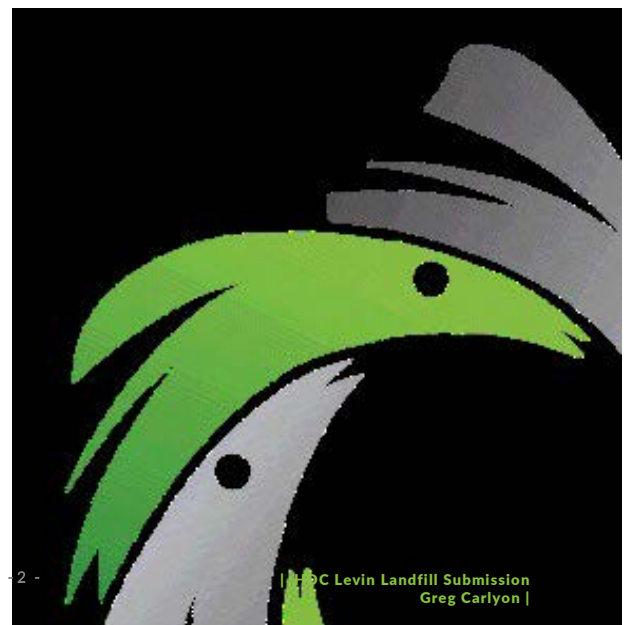
We also note there is a high level of disruption and pressure on the HDC team in relation to operationalising Council decisions at the present time. Accordingly, the reporting, review, and delivery of on ground outcomes for the landfill remains uncertain and as a result it is our view that it remains likely ongoing noncompliance will occur at the site. We note current Council initiatives to address this and look forward to addressing these matters in line with the landfill agreement.

The Project Management Group strongly supports Council's adoption of Option 1 for closure of the Levin landfill in 2022 and we seek the opportunity to present our teams views to Council in the coming hearing process. We also look forward to working with you and your Councilors to rebuild the relationships with the Hokio community over the coming year.

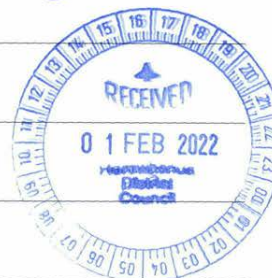

As set out in this Statement of Proposal the Council is considering options for the future of the Levin Landfill and before it makes a decision it wants to know your views. It is important to note that whichever option is decided the Council will continue to offer the current kerbside collection service and continue to aim to maximise recycling.

No matter how extensive the Council's waste reduction and recycling activities are there is an ongoing need for environmentally responsible residual waste disposal. The reasonably practical options considered are:

Option 1

Close the Levin Landfill in 2022

Council-controlled waste would be transported to an out of district landfill based on a disposal contract. The contract would need to state that the out of district landfill must continue to meet its environmental requirements. The Levin Landfill would be closed and capped. The site would continue to be monitored and managed for many years to ensure any ongoing environmental effects of both old and modern landfills were dealt with.

Option 2

Close the Levin Landfill in 2025

Between 2022 and 2025, operations would continue at the Levin Landfill. The Landfill would continue to accept a mixture of Council's waste and other waste. The Landfill would be closed by the end of 2025. After this date Council's waste would be transported to an out of district disposal location on the same basis as Option 1 and Council would continue to monitor and manage the Levin Landfill site.

Option 3

Close the Levin Landfill in 2037, or sooner if full

Operations would continue at the Levin Landfill until expiry of its consent to operate in 2037. The Landfill would be closed earlier if it reached its consented capacity before 2037. The Landfill would continue to accept a mixture of Council's waste and other waste.

Monitoring and management of effects during operation and after closure would occur to ensure it operated within its consents.

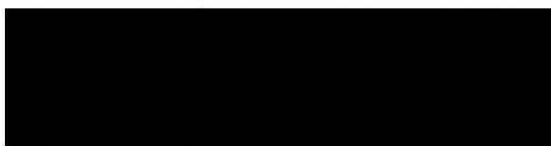

We HEKA have been involved as part of the Community Neighbourhood Liaison Group (CNLG) in informing the District Council (HDC) & Regional Council (HRC) of the non-compliance of Levin's Landfill for the last 10 years.

We are delighted to have this opportunity to support this closure, as the landfill and its governance has had an extremely detrimental effect on the environment and local community.

The District Council redirecting the contaminated (overland) water under Hōkio Beach Rd, into the Hōkio Stream is not OK. This contamination is very bad for humans and the environment – the testing of the water in the drain coming down from the tip face, shows terrible contamination with heavy metals and other carcinogens.

None of this is good for the people of Hōkio, the fish, our kai for eating or our swimming spots in the stream and ocean. Kai gathering is an important part of life for the residents of Hōkio.

Attached is my diary that I have been keeping since 2017 – my reporting of odours have not been verified as HRC do not have a local person to verify; instead choosing to either drive 45 minutes to check the smell (by then it's gone) or not bother to attend at all (more likely). I/we are never believed, the way the councils have treated the community is most upsetting.

Personally, I have had enough of the constant smell on Hōkio Beach Rd, and at my home in Hōkio. It's a gassy smell that leaves me light headed after a whiff.

Ngāti Pareraukawa has objected to the development and operation of the Levin Landfill since its establishment. It is an unsuitable site (on porous sand country with shallow ground-water, close to a stream and the ocean and upstream of a coastal village) and poses a significant risk to the environment, community health and safety, and cultural values of this area. We have **objected formally and informally for many years. We have maintained the stance that it should be closed as soon as possible and the area completed restored.**

The hapu supports the decision made by HDC to close the landfill in 2022. We expect the decommissioning of the start of the program of environmental restoration.

We note that the extensive study by expert consultants has clearly concluded that **Option 1 - Closure of Levin Landfill in 2022** is the preferred option. This is when all aspects – Cultural, Environmental, Financial, Social and Economic are considered. This action is also in line with HDC waste management strategy, and government indications regarding waste minimisation and management, and is the best option when greenhouse gas emission control is considered.

The Hōkio Landfill is too small to be viable or economically justified and is environmentally unsustainable. Any attempt to keep it open would expose HDC to significant environmental, financial and legal risk.

We look forward to a more positive and constructive relationship with HDC. We trust that the antagonism, litigation and mistrust of the past can be put behind us. Once the landfill is closed and the area restored we anticipate that Hōkio will become an attractive village and an asset to Horowhenua rather than an embarrassment.

Introduction

I welcome the opportunity to submit to this Council for the record in relation to the Hokio landfill.

My name is Jenny Rowan, and I am the community appointed representative for the Hokio community (Neighbourhood Liaison Group) along with David Moore on the Hokio Landfill Project Management group (PMG).

I am presenting this submission as an individual, as the PMG is also presenting a submission.

At the outset, I would like to congratulate those councillors for their initial support to close the land fill in May/June of this year. Being on the right side of history in this matter will count, as future generations come to understand the reasons why this non complying and poorly managed landfill needed to close.

Brief History

As a former Mayor of Kapiti, I attended the opening of this present landfill , with Mayor Duffy. It was a modern design for that time, and it was “my” Council that signed off for Kapiti rubbish to come to this landfill. A very good deal for the Horowhenua, and very convenient contract for our Kapiti community.

But even then, the local community and local mana whenua where very upset by this development. As far back as 1994, locals had tried to stop the extension of the landfill at Hokio, as the Horowhenua District Council (HDC) closed its other smaller dumps.

In 1997 HDC obtained resource consent to establish a new landfill at the same site, (Hokio), but these consents where appealed, and a consent order was issued in 2002 approving the current activity.

Some twenty five years later, we are now faced with the reality that because of a lack of consistent good management, and very poor policing from the Horizons Regional Council, over the last decade, this landfill is potentially a major long term environmental polluter.

As you know there has been an Environmental Management Review, in 2008. A damning report completed by Dr Jan Wright, who was the then Parliamentary Commissioner for the Environment, was tabled and there was a subsequent Environment Court hearing. The community has had to fight every inch of the way to bring this matter to a close, and it is only because the last Environment Court hearing set up the PMG, that we are here today seeking your courage to vote to close the landfill, and do the right thing.

This is an important process to understand, that the PMG comes under the instruction of the Environment Court - we are not here by accident. The main purpose of the PMG was to close this landfill, restore the site, ensure appropriate monitoring and heal relationships with community and local iwi by way of an apology.

Future Waste Disposal

At this point I would like to cover off concerns about what this community is going to do with its waste, once the Hokio landfill is closed. There seems to be an expectation that the PMG would look at this question and give you some guidance.

This was not a part of our brief, and quite frankly we had enough work to do to get us this far. It is your decision to make, but as I have stated previously, your community waste now needs to be managed in a way that the landfill complies at every level, and that there are economies of scale to ensure that this happens. Gone are the days when you find another gully to fill. Bonny Glen or the Porirua landfill are your obvious answers.

I am aware that there is discussion going on about green waste, and whether could this go to Hokio. I would be totally opposed to this development, but do see that there could be an opportunity for a modern well run green waste station nearer Levin, that could service the needs of the community, just like the green waste station at Kapiti. The Hokio landfill is too far out of town for this idea to work well. You would need to do a business plan, and this is another matter that would have to be discussed inside your Long Term Plan process with your community. But I am told you have tried to do this before, and the community complained, so it was abandoned.

The Role of Horizons Regional Council

The community's relationship with the Horizons Regional Council (HRC) over the years has been very unsatisfactory in relation to the Hokio Landfill. I do believe that if there had been proper monitoring and attention to the conditions and rules governing the landfill we would not be here today. To have a consent that could have been operating until 2037 is significant, that has now been compromised.

Many attempts have been made to assist the Regional Council officers to do their job, by community members, especially in relation to the odour issues that face the local community. But our suggestions were never taken up, and the total lack of engagement by the Regional Council officers has been very disappointing.

Hence the odour matters are still alive, arguments over record keeping are still unresolved, and even when the landfill is closed and capped, we need assurance that the leachate leakage in to the Hokio stream will be attended to.

The community have always seen the leachate leakage matter as part of the whole landfill site and have never accepted that because it is not leaking from the present site it doesn't matter. The fact that any leachate is going into the stream is unacceptable by today's standards. That it is tolerated and argued by a statutory authority that is supposed to ensure this doesn't happen is hard to swallow.

The community is looking forward to a more positive relationship with both HDC and HRC in the future, as the PMG works through the issues that need to be addressed as the landfill is closed.

Conclusion

You are familiar with the Morrison Solution report recommendations, that set out the best financial outcome for ratepayers presented by **option one**, which is to close the Levin landfill in 2022.

This report is comprehensive, and stands alongside the other reports that have been commissioned, which you will also be familiar with. This matter is not just about money. Social, cultural and ecological issues have been taken into account, and all of these reports clearly show that the impact of this landfill is no longer acceptable and that it should close.

I do wish to speak to my submission, and thank you for your consideration of this matter.

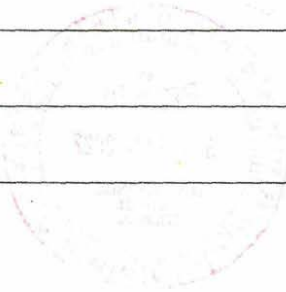

We the HPA agree with Option 1 – Close the landfill in 2022 .

Hokio deserves a Higher priority rating than it gets. It is not to be an effluent dump.

Hokio Beach Road and th environs are prone to flooding, and is less than 5 km from the ocean.

Our Argument- Breach of contract- HDC has compromised Landfill

Breach of Compliance-Unreported hazardous waste.

Breach of conditions- No remedy sought.

Breach of Agreement- No accountability to ratepayers/or Hokio.

As a community organisation, we are constantly contacted by community members who are adversely affected by the landfill. For too long we have 'put up' with Hokio being treated like a third world in terms of smell, seepage and big trucks taking up much of a narrow road - sometimes spilling waste when not covered; causing potholes and general road degradation. We also feel the impact of leachate into the stream from the landfill. Swimming at the beach in 2017 was Red Zoned , but deterioration now suggests not using the beach in close proximity to the both streams (Waiwiri and Hokio) for the purpose of fishing, gathering shellfish or swimming.

Hokio is a jewel in the Horowhenua and needs to be thought of and treated as such. We need a Higher Priority of Care. It is heartening to read that the landfill and dump site will be monitored for ongoing negative effects. To assist in the rehabilitation and to mitigate leachate reaching the stream. Scientists have indicated that wetlands do much to eliminate some of the toxins. We suggest the Tatana paddocks (in front of Landfill on Hokio Beach Road) be returned to

their natural state – wetlands. This will assist the remediation of the landfill but also ease flooding that is now a regular occurrence on roads in that particular area.

Wellbeing is important. After deciding Option 1 to be an outcome, then we suggest members of the Hokio community are amongst its participants to consider the ongoing processing. This is NLG and PMG.

For too long people have tried to access reports -to find these haven't been completed or not accurate.

We see inconsistencies in Horizons RMA's consents- Farmers and Others prosecuted - for example -(a) Discharge of effluent to land that may enter water. (b) Cease the discharge of a contaminants to land where it may enter water. (c) Offensive ,objectionable odour beyond the boundary. (d) No compliance for odour beyond the boundary. (e) Undertake stabilisation(NES-PF) to control sediment discharge. (f) Cease excess treated stickwater discharge to land of more than 100m³/day. (g) Not just failing to get in monitoring reports . (h) Methane burner did not stop all odours.

Accountability +Transparency need to come into Governance more.

Risks need to be heard at council ,not redirected by Mr Jones-FAR Chairperson. Health and Safety of all our people need to be respected.

RECOMMENDATION: vote for Option 1¹, close the landfill in 2022.

- ❖ *The best ranked financial outcome for ratepayers² is presented by Option 1, close the Levin Landfill in 2022, and elected members must choose to follow that professional recommendation.*
- ❖ *Continued mismanagement of the landfill is further reason to vote for option 1.*

Option 1 – “Close the Levin Landfill in 2022” has the best financial benefit to HDC’s ratepayers.² Options 2 and 3 offer long term financial pain for ratepayers, at the expense of some local business’ self-interests who wish to continue to dispose rubbish at the Levin landfill as opposed to Bonny Glen. The net present value costs of the options 2 & 3 do not take account of up to 14 years of inflation and therefore these costs are highly underestimated.

A: There comes a time when councillors must take a position that is neither safe, nor politic, nor popular, but must be taken because conscience tells it is right.

- Under a lack of governance direction, management have been able to instruct their highly paid lawyers to reduce environmental protections in the landfill resource consent conditions.
- Whether this is due to a lack of forethought or understanding, both Horowhenua District Council, as resource consent holder, and the Horizons Regional Council, as administrator, have allowed this to happen.

RECOMMENDATION: Elected councillors, as the governance group, take the responsibility for the sustained programme of mismanagement and degradation of the environmental protections and rectify the issues discussed herein within the next two years.

The **Resource Management Act 1991** is the legal framework for environmental protection. Specifically, **S15 Discharge of contaminants into environment** cites:

- (2) No person may discharge a contaminant into the air, or into or onto land, from a place or any source... in a manner that contravenes a national environmental standard unless the discharge is – (b) expressly allowed by a resource consent.

B: Mismanagement

1. In my view³, the approach taken by the Regional Council, does not meet the basic thresholds for compliance and enforcement required of an agency with clear statutory functions to address the environmental effects associated with (the Hokio Landfill) . The PMG has directly relayed its concerns to

the Regional Council at every level, with no action, and alternative approaches to addressing these issues should now be considered.

2. The Parliamentary Commission for The Environment became involved in the landfill mismanagement in 2008.⁴ The Levin landfill is in the Horowhenua District, four kilometres west of Levin. A landfill of some kind has existed on the site since the 1950s. For many years residents have been concerned about the environmental effects of the landfill site, particularly given its proximity to the Hokio Stream. Some of those concerns were addressed through resource consent conditions in 2002. Reported in 2008 there have been several historic breaches of the conditions requiring community liaison via the Neighbourhood Liaison Group. Other historic breaches, from as early as August 2004, were outlined in Appendix 1 of that document.

The Parliamentary Commissioner recommended **Horizons Regional Council establishes clear responsibilities for the timely monitoring and enforcement of resource consent conditions, ... and consideration is given to adopting an enforcement policy, the terms of which should provide sufficient support, guidance, and authority for future enforcement action.**

3. The 2002 Resource Consent Conditions were recently altered⁵ (*changes in accordance with Commissioners' Decision dated 18 November 2016 and changes in accordance with Environment Court Consent Order dated 19 December 2019*) are in HDC's management's favour thereby reducing HDC's potential (financial) liabilities. The changes do not benefit the local people, the Hokio catchment, or the wider environment.
4. The 2016 review (*changes in red*) was conducted between the District Council and the Regional Council and was done without the Neighbourhood Liaison Group's involvement⁶, and that was in breach of the Resource Consent. The 2019 review changes (*green*) were never presented to the NLG for ratification
5. Significantly, under the watchful eyes of many of the current councillors, HDC lawyers have, as recently as December 2019, inserted leachate remediation options⁷ ... the Permit Holder must complete an assessment of leachate remediation options (and a BPO) to: (a) cease, or if cessation is not feasible, materially reduce the discharge of leachate to the Tatana Drain and Hokio Stream; or (b) if neither of the options in (a) are feasible then options to offset effects within the Hokio catchment and if that is not feasible or possible options to compensate effects within the Hokio catchment or outside of it (either option through an ecological package). Also refer to point 21 below for deletion of conditions.
6. Compensatory money, and "outside of it" are open to interpretation as to who will be compensated how, paid by all Horowhenua District ratepayers. Iwi organisations are not the affected parties, it's the local landowners, and the residents who should be compensated.

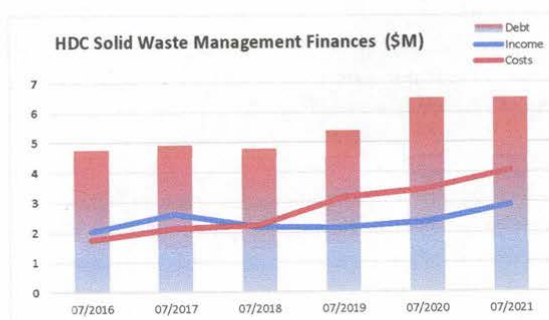
Ecological packages of riparian planting on the surface of the landfill or on the Tatana property will not stop leachate entering the aquifers and contaminating the Hokio Stream and its environs.

That is like putting flower beds around a toilet, that looks and feels good, but doesn't stop the already present underground contamination.

- Using the RMA clause 15(2)(b) above, HDC's altered the resource consent conditions which lawfully legalised contamination of the environment. The altered conditions reduce or negate the need to mitigate damage already present. No action has ever happened to protect the environment because the political cycle allows the incumbent councillors and staff to leave those issues for the next councils.

Environmental damage will continue for generations, long after those councillors making decisions will be dead, buried and long-forgotten.

- First and foremost, HDC's responsibility is to the long-term protection of the environment, economic impact on itself is a side issue. However, a resource consent condition states that any review requiring the reducing of adverse effects (of the Hokio Levin Landfill) shall have regard to financial implications for HDC⁸.
- Annual Reports (graph below) show that solid waste management finances, including the Hokio landfill have been losing approximately \$1 million per year for past few years.
- The Hokio landfill has not been economically sustainable in its current form, increased debt (borrowing) makes up the shortfall.

11. Social, cultural, and ecological implications and concerns, indicated in the Statement of Proposal¹ are not discussed in the Levin Landfill Resource Consents, only in the consultation document. Irrespective of that, financial implications mean spending ratepayers rates to fund the process. That requires open and transparent community involvement.

C: Landfill Odours have been compliant since 2017”¹ is downright wrong because credible complaints have not been verified by Horizons staff!

12. “Noxious or dangerous” odours are not words contained in the Landfill Consent conditions. Rather the clause reads: There shall be no objectionable or offensive odour or dust to the extent that it causes an adverse effect at or beyond the boundary of the site.⁹

13. Following is an example from local resident’s complaints reports.

This photo is of an accurate odour record. The credible interpretations of odour coming from the tip are not able to be verified as the correct complaints form¹⁰ was not used.

Neither Horizons nor HDC make any effort to supply the correct complaints form or direct complainants to use the correct form.

No enforcement action taken.

14. HDC lawyers removed the words “... adverse effects ...” (above) yet reports show odours of low intensity and high frequency can cause chronic effects, and odours of high intensity and low or high frequency can cause acute effects. Odours of low intensity and low frequency may cause chronic effects or may be infrequent enough that no adverse effect is registered by the community.¹¹
15. Were the frequent odour complaints from nearby neighbours credible because the odour caused health concerns? No enforcement action was taken, rather HDC purchased the property for \$705,000 when the GV was \$365k. Was this purchase a method to prevent the neighbours from further complaining and litigation?
16. HDC lawyers inserted a new clause Condition 4⁶ in 2016: *If an appropriately experienced officer of the Manawatu-Wanganui Regional Council or a suitably qualified independent expert considers that an objectionable odour beyond the boundary has occurred, having regard to: (i) a consideration of the FIDOL factors; and/or (ii) receipt of complaints from neighbours or the public having considered (i);*

and/or (iii) relevant written advice or a report from an Environmental Health Officer of a territorial authority, ... And the permit holder receives a request from the Manawatu-Wanganui Regional Council to provide them with a written report, then the report shall specify (d) the steps to be taken in future to prevent re-occurrences of similar events should this be necessary.

17. Credible reports of odours (FIDOL¹²) by nearby residents are not verified. With no verification of odour complaints, because the odour disappears during a verifier's travel from Palmerston North, or no travel for afterhours complaints, or no verifier employed, the stinking landfill odour is not verified. As such there is no non-compliance enforcement, and the matter is considered compliant.
18. Both the Resource Management Act and the Ministry for Environment Good Practice Guide for Assessment and Management of Odours have no reference to verification or verifiers of odour. Nearby residents were specifically removed as verifiers, even though they are listed in the Ministry for Environment Guidelines. Consider the get-out-of-jail phrase should this be necessary. Who determines this, against what criteria? Note The Commissioner's recommendation above.³
19. Complainants are not made aware by HDC or HRC of an official odour complaint and assessment form.⁷ This lists the FIDOL requirements, including 10 minutes of constant monitoring every 10 seconds and recording any the 40 different odours (below), intensity reference and wind effect detected. Signed in front of a Justice of the Peace this document becomes a Statutory Declaration, able to stand in any court proceedings against HDC's non-compliance of its resource consent conditions. *It becomes a legal document for HRC's enforcement of resource consent conditions.*

RECOMMENDATION: Councillors instruct HDC management to provide this document to all complainants to ensure the correct procedures are used.

D: Leachate. "Leachate from the old unlined landfill has a negligible impact on the water quality in the Hokio Stream. No evidence of leachate escaping from the new (lined) landfill."¹³ Those statements are downright wrong!

20. Leachate is the waste generated by the decomposition of waste within the landfill and the movement of water through the waste, either due to the rainfall infiltration through the landfill service, or the lateral movement of groundwater. The closed or inactive landfills that operated from the 1950s to 2004 are unlined and leachate seeps into the ground and mixes with the groundwater that is moving beneath the landfill.¹³

21. The Resource Consent Condition¹⁴ ~~Landfill leachate shall not contaminate adjoining land~~ **There shall be no overland flow discharge of leachate beyond the site boundary.**

~~2A In order to reduce the flow of leachate influenced groundwater to the Tatana Drain and through neighbouring land to the north of the landfill and to minimise adverse effects on downgradient surface and groundwater, the consent holder shall undertake the following actions~~

~~d) Conditions 2A a), b) and c) shall be completed with a fully operating interception, treatment and disposal system within 18 months of the commencement of the condition changes in the 2015 review decision¹⁵.~~

22. HDC lawyers changed the issue of leachate to become overland flow, rather than seepage of leachate in the aquifers as initially. They removed the condition "*shall be ... a fully operating interception, treatment and disposal system within 18 months of the commencement of the condition changes in the 2015 review decision.*"

Significance: a fully operating interception treatment and disposal system for leachate was to be operational in 2017. That was requirement was removed (why) and the leachate flow in the underground aquifers was no longer acknowledged as a problem to be mitigated.

23. The flow of leachate in the Tatana Drain, under Hokio Beach Road then into the Hokio Stream is an "overland flow". The water is above the land, and for that reason it is indeed "overland". **Compliance enforcement action is required.**

24. How much influence the leachate has on the Hokio Stream is a red herring issue. Leachate entering the Hokio Stream does have an impact on the water quality.

25. "Reports, based on a 10 year record, indicate a deterioration in the water quality and Hokio Stream between the upstream and downstream monitoring sites. Monitoring of the Hokio Stream and Tatana Drain indicate non-compliance with the required ANZECC EA (95%) trigger values; however, there is no comment on the significance of the non-compliance or the need for further investigation or remedial measures as required by condition 11 (aa)."¹⁶ **Compliance enforcement action is required.**

Comparative photos of freshwater entering and leaving Lake Horowhenua: left is clear water at a spring at Western Park discharging freshwater into Lake Horowhenua. The lake is the recipient of large quantities of runoff water from horticultural and agricultural land, as well as urban surface water runoff. The Lake is highly polluted with nutrients and sediments which runs out through the Hokio Stream,

where the dirty, polluted stream water meets the confluence of the Tatana Drain and Hokio Stream (right picture).



26. *HDC lawyers ensured that Nitrate-Nitrogen is not included as a trigger leachate¹⁷. Therefore, HDC cannot be held to be non-compliant for exceeding Nitrate-N leachate levels!*
27. The most recent nitrate data from bore B2 reports non-compliance, exceeding the ANZECC LDW standard in both July 2020 (133 mg/L) and in October 2020 (93 mg/L).¹² Ammonia-N at the downstream sampling site on Tatana Drain exceeded the Horizons One Plan concentration in three samples collected from October 2015 to July 2016. The range from 1.4 - 4.9 mg/L can be compared with the One Plan target of an average concentration of 0.4 mg/L and a maximum of 2.1 mg/L. No enforcement action has been taken. **Compliance enforcement action is required.**
28. HDC's statement that "there is no evidence that any leachate is escaping from the new Landfill" is downright wrong.
29. Leachate broke out of the western side of the lined landfill on 12 May 2017.¹⁸
30. Acute toxic levels¹⁹ of nitrate-nitrogen have been detected and reported²⁰ in the aquifer downstream of the lined landfill since 2006 (see below). Levels have been 1300 times higher than the average background aquifer levels, or about 10 times higher than the maximum allowed in drinking water standard of 11.3 mg/L in drinking water, which is far above the levels associated with adverse health outcomes observed in recent epidemiological studies (as low as 3.9 mg/L).²¹

The data above was supplied by email from HDC's LGOIMA officer on 29 November 2021.

The Nitrate-N levels in aquifer boreholes D1 and D6, located downstream from the lined landfill are shown to increase from APRIL 2006.

That is undeniable proof that leachate pours out from the lined landfill.

Compliance enforcement action is required.

31. The liner has a shelf life of about 100 years, when it degrades more leachates will leak into the aquifer.
32. Non-compliances of resource consent conditions were recorded 26, 20, 18 and 16 times in 10 monitoring locations during the quarterly reports for 2021.²² Yet, when trigger values are exceeded, as above, HDC has only have to consult with Horizons Regional Council to determine **if** further investigation or remedial measures are required.

Neither body has undertaken any compliance enforcement or remedial action for these notifications.

E: RECOMMENDATION: HDC and HRC need to be held accountable for maintain compliance to the resource consent conditions through to the 2037 closure and beyond:

33. Through peer-review of the Levin Landfill Pattle Delamore Partners Ltd²³ found issues with monitoring methods and that the contamination from the landfill does cause effects on the Hokio Stream that exceed the water standard guideline values. **Compliance enforcement action is required.** However, this appears not to have been taken by both HDC and HRC. Why not?
34. HDC is non-compliant in not establishing a meteorological weather station²⁴ which was required since November 2016 to collect daily weather data. **The Consent Permit Holder shall collect meteorological data from an on-site weather station.** HRC's lack of action shows its irresponsibly after 5 years of non-compliance. **Compliance enforcement action is required.**
35. HDC is non-compliant: "The Permit Holder shall ensure the NLG members are²⁵: Given the opportunity to inspect the operations on site on the occasion of NLG meetings, and/or on such other occasions as are

agreed by the Permit Holder and Landfill Operator. The Permit Holder and the Landfill Operator shall not unreasonably withhold such agreement.”

- HDC management has prevented an NLG member from verifying data collection on the grounds of health and safety. **Compliance enforcement action is required.**

36. HDC is non-compliant: cover at the end of the day²⁶ to keep odours down frequently not done. Uncovered rubbish appears at the surface. Well-grown bushes indicate this area had been an inactive tip front for a considerable time, and therefore long-term noncompliance. Wind-blown rubbish on the right hand side further shown lack of compliant daily cover. Photos below were taken during weekends, when contractors were not working through absence.



Bushes growing through the rubbish on landfill Stage 1A shows the cover had been undisturbed until drone photos were published by the Catalyst Group.

After publication the piles of sand seen here were placed to form an intermediate cover.

The intermediate cover is non-compliant as the sand appears to be lacking the required wood mulch mixed in with sand.

Compliance enforcement action is required.

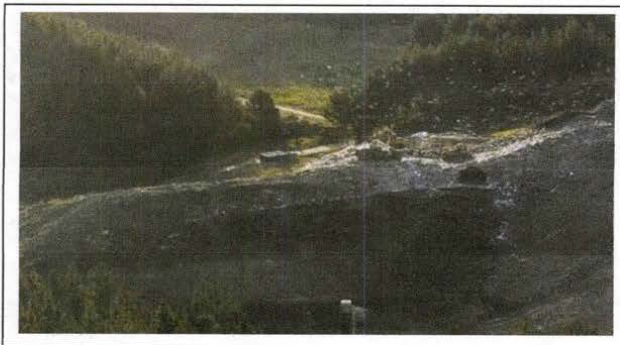

37. Non-compliant: the intermediate cover laid over the landfill should be sand and mulched wood, not sand alone. **The combined depth of intermediate cover, including daily cover, over the waste shall be a minimum of 300 mm and may must comprise of uncontaminated soil, and/or a mixture of sand and mulched woody material.**²⁷ **Compliance enforcement action is required.**



38. Non-compliant: monthly sampling of Hokio Stream, Tatana Drain not undertaken due to miscommunication between HDC and the monitoring contractor²⁸ **Compliance enforcement action is required.**

39. HDC is non-compliant: gulls and scavengers were feeding at the tip site.²⁹ **Compliance enforcement action is required.**



40. Quarterly reporting monitoring (Permit 6010, Condition 2Q) consistently doesn't occur quarterly.³⁰ See Table below. While the sampling is supposed to be January, April, July and October, 2 of the past 3 years reports have been conducted in consecutive months or 5 or 6 months apart.³¹ Or is that because someone in management does not put the correct information on HDC's website? **Compliance enforcement action is required.**

41. Inaccurate and unreliable quarterly reporting¹⁸ where the same values are recorded in consecutive reports: July and September 2019, and May and June 2020.

Note that the down-gradient boreholes are 10-15 times higher than the background borehole levels.

How can readers have confidence in compliance reports when repeated value inaccuracies exist?

42. Area 2 one of two (1970s) old landfill sites is outlined in yellow. According to local knowledge this was the main recipient area for sewage sludge. It remains uncapped.³² **Compliance enforcement action is required.**

15. The Permit Holder shall close and remediate the existing unlined landfill by April 2011 by:



The 2005 photograph of the landfill site, supplied from Horizons Regional Council appears to have been taken before the planting of pine trees, showing both Area 1 and Area 2 were uncapped at the time the resource consents were considered and published.

Compliance enforcement action is required.

43. HDC requires NLG members to ask for secret reports that members know nothing about because they're not told of their existence. "Copies of this LMP shall also be made available to the members of the Neighbourhood Liaison Group (NLG), on request."³³ How can the members request copies of papers they do not know exist? **Compliance enforcement action is required.**

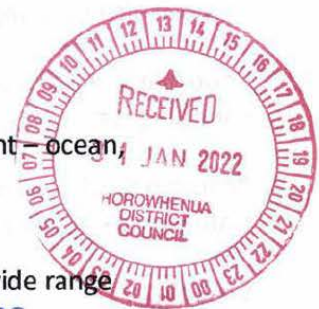

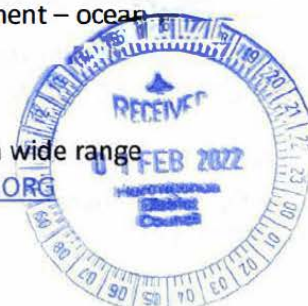
