


# **SmartyGrants**


Horowhenua District Council uses SmartyGrants (a hosted grants management application) that allows us to receive and manage applications.

Users who are registered with SmartyGrants will already have a login. Otherwise, to register, head to smartyfile.smartygrants.com.au/applicant/register

To log in, head to app.smartyfile.com.au



Once logged in, you will have the opportunity to create an organisation. Click on 'New Organisation' to create a profile.



Complete your organisations details.

You will then be able to pre-fill this information for all future grant applications, saving you valuable time.



- To assist in the promotion of financial literacy.
- To provide opportunities for all New Zealanders to achieve economic and social independence.
- To provide access to learning opportunities that prepare people for meaningful work and a high quality of life.
- To assist people working together to create viable and secure communities.
- To assist communities to conserve New Zealand's natural and historic resources.

# What they don't fund:

- Schools
- Sports clubs
- Endowments
- Fundraising events or campaigns
- Fixed assets, including equipment
- Capital investment, e.g. new buildings
- Normal operating and administration costs, including salaries. However, consideration will
  be given to funding the cost of providing specialist services, e.g. funding for 20 one-hour
  sessions with a specialist counsellor at an hourly rate per session.
- Debt repayment and operating budget deficits
- Costs of attending overseas conferences
- Travel costs
- Organisations that ANZ New Zealand is already sponsoring
- Organisations that have already received funding from the Foundation in the previous 12 months.
- Charitable projects that are not New Zealand based.

### Timeframe:

- Two funding rounds per year.
- February opens 1st January, funds to be used between May and October.
- August opens 1<sup>st</sup> July, funds to be used between November and April.
- No organisation can receive funding in two consecutive funding rounds unless the funding rounds are more than 11 months apart

# Top tip:

A maximum of \$25,000 can be requested by each charity per funding round.

- Applications that benefit the community.
- Salary and operating costs
- Specific project costs
- Health
- Arts
- Education
- Sports including equipment, travel and operating costs.

# What they don't fund:

- Individuals.
- Fund overseas travel for groups or individuals.
- Entry fees.
- Catering or bar related expenses.
- Other trust funds, capital funds or endowments.
- Underwrite fund-raising projects.
- Political parties or groups aligned with political parties.
- Support the spiritual activity of religious organisations.
- Fund debt retirement.
- Retrospective applications (projects which have been completed or costs committed before you have been informed of your funding decision).
- Commercial organisations or for the commercial activities of not-for-profit organisations.
- Local government or central government departments for activities that could be deemed their responsibility.
- Fund expenditure related to core curriculum delivery in schools, teachers' salaries and operational expenses.
- Projects where the beneficiaries are outside AGT's funding areas.

#### Timeframe:

Receive grants year round.

# Top tip:

They only accept applications from not-for-profit organisations.

Grants of \$30k or more are reviewed monthly.

Grants under \$30k are processed within 20 working days – so for a quicker turnaround keep grants under this amount.

- General public education
- Education scholarships (provided the students are selected in a fair and open manner after public advertising, and are overseen by a recognised educational authority or school board, and provided that they are limited to primary and secondary level.
- Non-profit community cultural or arts festivals.
- The promotion of public amenities such as parks or museums.
- Supporting non-commercial emergency rescue services.
- Grants to recognised charitable organisations (e.g. Plunket, Salvation Army or Red Cross) to further the objectives of these groups.
- Public sports facilities (e.g. a stadium) provided that the facilities are not used primarily for professional sport.
- Amateur Sport
- Amateur sports coaches for specific short-term coaching courses and coaching clinics for junior sports people.
- Ground maintenance for amateur sporting facilities.
- Overseas travel to genuine amateur sporting tournaments.
- Trophies and modest non-cash prizes.
- Wages and salaries where the employing body has an entirely non-commercial community or charitable purpose and provided that the payment of a wage is necessary to achieve the authorised purpose.

# What they don't fund:

- Groups or individuals standing for an election to public office.
- Lobby groups or action/pressure groups (e.g. Greenpeace, or Sensible Sentencing Trust).
- Social events, e.g. school balls, family reunions, entertainment in pubs or clubs, sporting trips for supporters or spectators, or after match functions for sporting groups.
- Personal or commercial gain.
- Professional sport or "social" sports clubs (such as corporate leagues).

### Timeframe:

Monthly. Cut-off date for applications is the 10<sup>th</sup> day of each month.

The Catalytic Community Grants fund small to medium sized, community-based organisations, who do not have large in-house marketing or fundraising resources and are providing direct social services to whanau/families and individuals.

# What they fund:

- Project costs
- Social services
- Purchases under \$3,000
- Operating expenses including: rent, utilities, salaries/wages.

# **Priority Areas:**

- Whanau/Family
- Early years support
- Youth development
- Accommodation/housing
- Food security
- Community services
- Maori and Pacifica communities
- Refugee, migrant and multi-cultural communities
- Skill development / financial literacy

# What they don't fund:

- Schools
- Core early childhood education programmes
- Government agencies
- Art organisations
- Sport organisations and sports equipment
- Animal charities
- Fixed assets or purchases over \$3,000
- Capital projects
- Overseas travel
- Medical treatment
- Individuals
- Health related organisations

#### Timeframe:

The fund closes in October each year. Successful applicants will be notified at the end of November.

# Top tip:

Most Grants are between \$2,000 and \$10,000 so target your application to this range.

# **Lottery Community Grant**

Lottery Community grants are available for not-for-profit organisations with a community or social service focus for ongoing operating costs or projects which help improve the quality of people's lives in their communities.

# What they fund:

- Ongoing operating costs for existing or expanded services and activities
- Projects beyond an organisation's day-today operations
- Helping to top-up an organisation's existing funding
- Minor capital works projects where the total project cost is \$50,000 or less.

# **Priority Areas:**

- Māori, whānau, hapū and iwi
- Pacific people and other ethnic communities
- Older people, women, youth and people with disabilities.
- Parents/families/whānau
- Children and youth development
- Enhancing the quality of life of older people in the community
- Preventing violence
- New migrants/refugees
- People with a long-term/significant disability or illness
- People who are considered to be at risk or disadvantaged
- Improving people's knowledge and use of digital technology.

# What they don't fund:

- Individuals
- Research, including: large scale research plans, feasibility studies for capital projects and health research

- Major capital works where the total project cost is over \$50,000
- Food for food banks
- Alcohol and similar substances, for example kava

#### **Timeframe:**

Two rounds of funding are available. Round 1 – opens end June and closes end July each year. Decisions notified at end of October.

Round 2 – Opens end October and closes end November. Decisions notified at end of March.

# Top tip:

Second funding requests are low priority - If your organisation received funding from the previous Lottery Community funding round (within a year) then any requests made in the next funding round will be considered low priority unless there are exceptional circumstances for making your request.

# **Lottery Community Facilities Grant**

The Lottery Community Facilities grant is available to improve or build new community facilities, or for feasibility studies to work out if plans to improve or build community facilities can be achieved and will benefit the community.

#### What they fund:

- Projects where the total project costs is over \$50k
- Projects to build new community buildings or facilities
- Projects to improve or enlarge existing community facilities
- Feasibility studies to work out if planned projects are needed, can be achieved and fit the long-term vision of the community
- Seismic assessments
- Building purchases (but only if this is a better and less costly option than building a new facility).

# **Priority Areas:**

- Project is community-led and well supported by your community
- Will meet a community need
- Is the right size for your community
- Will provide new opportunities for people to be involved with and connected with the community, especially:
  - o rural and isolated communities
  - o disadvantaged groups
  - people who can't easily access similar or suitable community facilities.

# What they don't fund:

- Repaying or servicing debt
- Refinancing loans, deposits or underwriting projects
- Commercial, political and/or religious objectives, including employment and/or business initiatives, commercial enterprises, political advocacy or projects which seek to change legislation

- Fundraisers and projects which seek to raise funds in or for a specific sector, or are involved with the training or employment of fundraisers
- Projects which seek to redistribute funding to others
- Overseas aid or disaster relief
- Alcohol and drug treatment, education and support services
- Medical expenses, operations, treatments or the purchase of major items of health equipment
- Capital investment or trust funds
- Projects or activities completed (retrospective funding) or items bought before the request.

#### Timeframe:

Round 1 – opens mid-July and closes beginning September. Decisions notified mid-December. Round 2 – Opens 1 January and closes end February. Decisions notified early June.

# Top tip:

This fund has 46% less funding available compared to previous years. This means the committee will not be able to fund as many requests. Contact a Lottery Community Facilities Advisor to discuss your requirements for a feasibility study first before submitting an application.

# **Lottery Community Facilities Grant**

The Lottery Minister's Discretionary Fund is available to not-for-profit organisations and individuals for projects that fall outside the scope of the Lottery Grants Board distribution committees. The Lottery Grants Board also provides funding for natural disaster emergencies recovery through the Lottery Minister's Discretionary Fund.

# What they fund:

- Overseas travel (including attending international, website-based and conferences remotely)
- Web-based events and attending remotely
- Volunteer firefighting and emergency ambulances services projects
- Animal Welfare projects
- Leaning and development projects
- Financial planning and/or good governance training
- Te Tiriti o Waitangi and Te ao Māori training
- One-off learning and development projects where two or more community organisations benefit.

#### What they don't fund:

- Registration or training that maintains an individual's registration with a professional organisation
- Requests for business-as-usual activities
- Vehicles for emergency ambulance services
- Permanent residential housing services or community housing
- Gambling education, prevention or treatment services
- A second request for the same project or location of benefit in the same funding year

**Timeframe:** Ongoing – monthly intakes

#### Top tip:

Only individuals can request funding for overseas travel and will need to show how they will share the information gained from their attendance and how attending the conference will benefit the New Zealand Community or a significant sector of the New Zealand Community.

This fund is where you apply for your operational support, events, programmes, capability and capacity building and small repairs and maintenance.

#### What they fund:

The Grassroots Fund has three outputs under which organisations can apply for funding: participation, community services and education.

# Participation activities could include:

- Operating costs
- Programme costs
- Coaching
- Events
- Equipment
- Small assets (like vehicles)
- Repairs and maintenance (like kitchen or bathroom refurbishment)
- Grassroots, regional or local activities

Apply for this fund if you are a sports club, an arts, cultural or environment organisation, or if you are organising an event that will enhance community participation.

# Community service activities could include:

- Operating costs
- Programme Costs
- Events
- Equipment
- Small assets (like vehicles)
- Repairs and maintenance
- Grassroots, regional or local activities

Apply to this fund if you provide social services, counselling, information or community support – this includes food banks.

### Education activities could include:

- Equipment
- Small assets (like vehicles)
- Events
- Collaborative projects
- Pools

#### What they don't fund:

#### Participation:

- Affiliation or membership fees
- Property that doesn't belong to the organisation

- Events that offer prize money
- National-level or elite activities
- Training and capacity development
- Funding for individuals

#### Community Services:

- Affiliation or membership fees
- Property that doesn't belong to the organisation
- Training
- Unincorporated groups
- Activities funded by Government
- Funding for individuals

#### Education:

- Operating costs
- Salaries
- Professional development
- Funding for individuals
- Transport to and from school
- Projects that would reasonably be considered to be the responsibility of central or local government.

### Timeframe:

There are no closing dates so applications can be made year round.

Eastern & Central Community Trust aims to provide a decision within three months of receiving an application.

### Top tip:

Organisations can only receive one Grassroots grant in any financial year (April-March), so make it a good one!

Harcourts have a clear focus on providing grants to reputable community-based organisations which need funding for projects and initiatives designed to benefit as many people as possible. Priority will be given to applications that demonstrate that their grant will have the widest community impact.

#### What they fund:

- The advancement of social and community welfare in New Zealand.
- The relief of poverty in New Zealand.
- The care, support and protection of the aged, children, and young people and people with disability in New Zealand.
- The promotion of community development to enhance social and economic participation in New Zealand.
- The promotion and fostering of art and culture in New Zealand.
- The promotion of education in New Zealand including the establishment and support of schools, universities and other educational establishments.
- The provision of facilities for the education of pupils of schools, universities or other education establishments.

#### What they don't fund:

- Individual needs such as salaries and wages. Our focus is on supporting as many people as possible within our communities.
- Administrative or operational costs.
- Overseas or other travel costs.
- Religious, political, or hobby causes or activities.
- Marketing/advertising (i.e. printing, clothing).
- Catering
- Grants will not be given for items already purchased or initiatives/projects already held.

#### Timeframe:

Application rounds 2023 / 2024:

- Round 60 | 1 November 2023 30 January 2024
- Round 61 | 1 February 2024 29 April 2024

Decisions are due to be made within 3 weeks after the round closes.

Link application back to the foundations primary objectives in order to increase your chances of a successful application.

Funding opportunities are available to conserve and protect heritage places across Aotearoa New 7ealand.

### What they fund:

A number of funding options are available:

- National Heritage Preservation Incentive Fund The National Heritage Preservation Incentive
  Fund (NHPIF) provides a subsidy for the conservation of privately owned places included on
  the New Zealand Heritage List/Rārangi Kōrero.
- **Te Tahua Taioa Ngā Taonga** | **Lottery Grants Board Environment and Heritage Fund** The Lottery Grants Board Environment and Heritage Fund provides funding for projects that promote, protect and conserve Aotearoa New Zealand's natural, physical and cultural heritage.
- **Oranga Marae** Oranga Marae is a programme of support, advice and investment for marae. The programme aims to strengthen the ability of marae to pass on their ancestral knowledge of whaikōrero, karanga and local mātauranga, tikanga and kawa.
- Regional Arts and Cultural Heritage Fund The Regional Arts and Cultural Heritage Fund is a
  contestable fund of last resort which contributes typically no more than the last third of the
  qualifying capital project's cost.
- **Professional Development Grant** The Professional Development Grant funds access to local and international museum and gallery training programmes.
- Unreinforced Masonry Buildings Securing Fund The Unreinforced Masonry Buildings Securing
  Fund supports owners who are required under the Building Act 2005 to secure street-facing
  unreinforced masonry.

### What they fund:

Trustees have preference for projects that meet one or more of the following criteria:

- Innovation are bold and push the boundaries rather than maintain the status quo
- Uniqueness involves work no-one else is doing and fills a unique gap
- Impact have an enduring benefit and/or the lessons learned can be more widely applied

# The Rainbow Wellbeing Legacy Fund

#### What they fund:

The intention of this fund is support projects, activities and organisations to improve mental health outcomes for future generations of rainbow communities, particularly for young people.

The fund will allocate grants with a view to improving, sustaining and/or supporting the mental health and wellbeing of the rainbow community. Grants will be targeted at activities that improve the capacity and capability of communities to support rainbow mental health and wellbeing.

# Projects can be:

- Community, cultural, research, sporting or creative activities that support and enhance the wellbeing of communities
- Developing capability, for example: training for staff, volunteers and members in rainbow community organisations; developing and disseminating mental health and wellbeing resources; developing rainbow communities' leadership and self-reliance
- Activities/projects that work with specific rainbow groups that experience multiple forms of oppression including: Māori, Pacific peoples, rangatahi, migrants, refugees, bisexual, gender diverse and intersex people.

# What they don't fund:

- Funding will not be awarded for activities that are primarily the domain of the Ministry of Health, or other government agencies, to fund or deliver, or otherwise duplicate activities that are already funded.
- Individuals cannot be awarded grants. However, groups of people may apply but will need an organisation with a bank account to hold funds on their behalf.
- The RWLF can only fund costs related to a specific project. It cannot fund ongoing 'business as usual'costs. For example, rent or power costs.
- Annual Pride Festivals and events will not be funded by RWLF.

The majority of Te Māngai Pāho funding is contestable, mixed-platform funding, and is available to producers and creators to create a diverse range of Māori content, such as Special Projects, Tamariki & Rangatahi, Innovation, NZ on Air Co-Fund, General Audience and News & Current Affairs.

#### Māori music:

Te Māngai Pāho provides contestable pūtea tautoko to artists and producers who make reo Māori music for airplay and streaming. Oro Kura Roa; Waiata Takitahi; Oro Hāpai; Waiata Reo Māori; Waiata Tuarea; funding also is available for initiatives that widely promote and celebrate waiata reo Māori - Music Industry & Artist Support.

# What they don't fund:

Māori music fund does not fund the following:

- Applications from applicants with overdue Te Māngai Pāho contracts.
- Applications relating to songs that have previously received funding support.
- Applications received after the closing date and time.
- Applications that will propel an Individual (Sole Trader) applicant beyond \$15,000 (ex. GST), the maximum funding permitted to an Individual (Sole Trader) at any one time.
- Applications that better fit another funding stream.
- Applications for songs, samples, and music that the applicant has no right to.
- Incomplete applications.



# TRANSPOWER

# What they fund:

The CommunityCare Fund works by providing one-off grants up to the value of \$15k towards community-based projects with tangible, wide-reaching and lasting benefits to communities within 2km of there transmission lines.

The following organisations are eligible to apply:

- Organisation or community groups who are independent, local and non-profit
- Non-government organisations charities
- K\u00f6hanga reo, schools, or educational institutions
- Local iwi and hapū, local and regional councils, although an application from the community is strongly encouraged.

The CommunityCare Fund will consider funding for:

- Projects in communities within 2km of our overhead lines and who are affected by our assets
- One-off projects seeking a grant up to \$15,000
- Lasting projects that have wider-reaching benefits to the community
- Projects with a high level of community involvement and participation
- Committed projects with funds already raised from other sources.

### What they don't fund:

- Events
- Programmes or operational costs (e.g. salaries, rent, bills, fuel, administration costs, volunteer support, equipment hire, paying a project manager)
- Individuals, political organisations, or other foundations who make grants
- Projects generally funded by the government
- Projects that have already been completed

- Projects that may compromise
   Transpower's policies for managing the
   National Grid (e.g. a proposal to build too close or under our transmission lines)
- Organisations who have received a CommunityCare Fund grant in the last four years.

#### **Timeframe:**

There are two funding rounds per year:

- Summer round the window to submit an Expression of Interest is the month of October (closing date 11:59pm on 31 October). Full Applications then close 11:59pm on 31 January
- Winter round the window to submit an Expression of Interest is the month of April (closing date 11:59pm on 30 April). Full Applications then close 11:59pm on 31 July.

There is a two-stage application process to apply:

- Expression of Interest a short form so that they can check your proposal meets the funding criteria.
- Full Application where you can provide more detail if you meet the funding criteria and are invited to submit a full application.

Each of Z's service stations will choose four different community groups to support, giving away a total of \$4,000 at every site. Customers are given an orange token to pop in one of the four boxes, voting for their favourite local group. The money is split between all participating groups based on the number of votes each receives. In addition to the \$4,000, every Z service station has a further \$1,000 to be used by local retailers throughout the year to support other neighbourhood initiatives.

# What they fund:

Applications must meet all the following criteria:

- The group or project must be active in the local area around a specific Z service station; and
- The group or project must demonstrate they are providing support or help to people who need it or the environment; and
- The request must be for a specific project or to fulfil a specific need.
- The person submitting the application must be from the neighbourhood group or project on whose behalf they apply for funding.

# What they don't fund:

Applications from the following groups and projects won't be eligible:

- Groups or projects which don't actively help people who need it or the environment
- Nationwide organisations which don't have a branch in the neighbourhood around the station they're applying for funding from
- Applications for the promotion or benefit of one individual
- Commercial ventures
- Completed or retrospective projects
- Local or central government activities or projects
- Festivals, shows or events.

#### **Timeframe:**

- Applications open 1 July.
- Groups have until 31 July to get their applications in online. Each Z service station then chooses four different community groups to support.
- Successful groups will be advised in August.
- Results will be announced in November.

#### Top tip:

If you apply – make sure that you go into your local Z service station to introduce yourself to the manager and tell them a little bit about your group/project.
