General Business

Mayor Waden advised he has made a commitment for the NLG to present to Councillors.

Viv referred to a Solid Waste newsletter she had received which stated that 2 monitoring locations have been disconnected.

Hamish responded that the sampling sites are still required to be monitored under consent and requested to see the newsletter. Hamish will then follow up as required.

Charles noted it was the first time he had seen the report and NLG should be receiving it.

Asli reported that it is available on HDC's website.

Hamish had hard copies of the Horizons Compliance Report to 19 December 2019 for those who would like to take one.

Christine stated there had been 20 odour events between 21 February and 19 June; most of these occurred during lockdown and Christine noted she was advised by HRC that they could not do anything about it.

Hamish responded and agreed there were odour events received during Covid Lockdown Levels 4 and 3 at which time HRC were unable to attend due to the restrictions in place.

There was further discussion between Hamish and Christine with the outcome being that Hamish would like to receive Christine's odour list to ensure they are recorded in HRC's system.

Christine further advised that Tatana's have dug holes and put more fill in around Tatana's Drain in the last 2 weeks in an area that is meant to become to wetland.

Christine has received reports that there are trucks from out of the area entering the tip at night and asked if that was in fact the case and if so, why? Christine noted she did not expect an answer this evening but would like an answer in due course.

Peter Everton introduced Eugene Henare an original NLG Member, Eugene commented that he would still like to think that the kaupapa, aims and objectives are still ahead of us.

Jenny advised that there will a report from Council regarding Landfill Closure at the next meeting in late September.

Hamish Sutherland and Charles will talk to discuss who is on the NLG.

Jenny asked that the NLG receive the process for reporting Odour Complaints to Horizons Regional Council. Hamish will prepare for circulation.
