Thank you for your email dated 17 February 2025 requesting under the Local Government Official Information and Meetings Act 1987 (LGOIMA), information relating to costs associated with elected members. Please see outlined below a response to each part of your request.

Elected Members' Remuneration: A breakdown of the total amount paid to each elected member, including salary, allowances, and any additional payments.

Elected members remuneration is set by the Remuneration Authority. The latest full Determination can be found here: <u>Local government members remuneration | Remuneration Authority</u>

Elected member vehicle-kilometre allowances clams are attached at attachment 1. Elected members can claim the vehicle-kilometre allowance where the member:

- is not provided with a motor vehicle by the local authority,
- is travelling in a private vehicle,
- is on local authority business, and
- is taking the most direct route that is reasonable in the circumstances.

We do not collect specific details of each journey.

Vehicle-kilometre allowances are non-taxable

Training and Travel Costs: Information regarding the costs spent on training and travel for elected members, including:



- The total expenditure for training and travel.
- Specific details on the training undertaken and the travel undertaken for this purpose (including the destination, nature of the training or event, and dates).
- If you are unable to provide any of this information, I would appreciate it if you could outline the reasons for withholding the information.

Additional funding is available for elected member professional development related to their roles, and covers attendance at courses and conference. The costs associated with elected member professional development are attached as attachment 2
