Tēnā koe | Dear

Thank you for your email dated 24 March 2025 requesting under the Local Government Official Information and Meetings Act 1987 (LGOIMA), information relating to cost of reports. Specifically, you requested

I understand that Council has engaged external consultants to provide data and analysis about the district's stormwater consent process. Can you provide the total cost of these reports over the past five years, the number of the reports and how they have contributed to Council's understanding of the stormwater network?

Over the last five years we have engaged consultants to work on stormwater consent applications for both Levin and Foxton Beach.

As well as providing formal reports these consultants assisted with other pieces of work including planning, liaising with other agencies, overseeing stormwater monitoring, ecological assessments and preparing consultation material for iwi engagement.

We have interpreted your question to refer to all work relating to stormwater consents over the last five year, and not just reports.

Council has recently recruited a stormwater engineer, after trying to fill the vacancy for some time. The stormwater engineer will be able to carry out much of the work for which we have previously engaged consultants.

In the last five years Council has spent a total of \$583,323.50 on consultancy services related to stormwater consents for Levin and Foxton Beach. Further details of the consultancy work undertaken are provided in Appendix 1.

The work carried out by the consultants has enabled us to progress the consent applications. It has also given us valuable understanding of the stormwater system and its impact on the surrounding environment, and ways in which improvements can be made.
