Council Officers are available to offer advice to and answer questions from Elected Members when the meeting is formally considering the agenda item i.e. on completion of Public Participation.

Meeting protocols

Proposed Boundary Alteration between Horowhenua District and Palmerston North City at Tokomaru and Opiki

1. Purpose

To outline the boundary alteration proposal process and present the draft Horowhenua District Council submission for endorsement.

2. Executive Summary

- 2.1 In October 2018, the Local Government Commission (The Commission) received a local government reorganisation application from the "Tokopiki Boundary Change Group" for a change in the boundary between Horowhenua District and Palmerston North City. The effect of the proposal would be to transfer the township of Tokomaru and rural locality of Opiki and adjacent areas from the district into the city.
- 2.2 The Commission released its public consultation document on Monday 1 March 2021, in response to a request to move the boundary between Horowhenua District and Palmerston North City, at Tokomaru and Opiki.
- 2.3 The Commission is seeking public feedback and submissions which close at midnight on Wednesday 7 April 2021.
- 2.4 A version 1 draft submission was distributed to Council seeking comments / feedback.
- 2.5 Taking Council's comments and feedback into account, a version 2 draft submission for consideration, will be distributed to Council and uploaded to Council's website on or before Tuesday 30 March 2021.

3. Recommendation

- 3.1 That Report 21/109 Proposed Boundary Alteration between Horowhenua District and Palmerston North City at Tokomaru and Opiki be received.
- 3.2 That this matter or decision is recognised as not significant in terms of S76 of the Local Government Act.
- 3.3 That the Horowhenua District Council endorses the submission to the 'Proposed Boundary Alteration between Horowhenua District and Palmerston North City at Tokomaru and Opiki'.
- 3.4 That Mayor Wanden and Chief Executive, David Clapperton, are authorised to make minor amendments to the submission, should these be required.

4. Background / Previous Council Decisions

- 4.1 The Commission released its public consultation document on Monday 1 March 2021, in response to a request to move the boundary between Horowhenua District and Palmerston North City, at Tokomaru and Opiki.

- 4.2 The Commission is seeking public feedback and submissions can be made up to midnight on Wednesday 7 April 2021.




Boundary Change Request Background

- 4.3 On 4 October 2018, The Commission received a local government reorganisation application from the "Tokopiki Boundary Change Group" for a change in the boundary between Horowhenua District and Palmerston North City. The effect of the proposal would be to transfer the township of Tokomaru and rural locality of Opiki and adjacent areas from the district into the city.
- 4.4 The group considered the area that would be affected by the proposed boundary change would be better served by being included within the boundaries of Palmerston North City.

4.5 The affected area that would become part of the city if the proposal were to proceed is shown in the map here:



The Process

- 4.6 On 4 April 2019 The Commission released a public notice inviting alternative applications in response to the application for a change to the boundary between Horowhenua District and Palmerston North City. The period for alternative applications closed on 15 May 2019.
- 4.7 An "alternative application" is a proposal for some other change to local government in the affected area that falls within the broad definition of "local government reorganisation" contained in section 24 of the Local Government Act. This may include the:
 - union of districts or regions
 - constitution of a new district or region, including the constitution of a new local authority for that new district or region
 - abolition of a district or region, including the dissolution or abolition of the local authority for that district or region



- alteration of the boundaries of any district or region
- transfer of a statutory obligation from one local authority to another
- assumption by a territorial authority of the powers of a regional council.
- 4.8 Any individual or group can lodge an alternative application including individual members of the public, community groups, businesses and organisations.
- 4.9 On receipt of alternative reorganisation applications, the Commission then identified what it saw as "reasonably practicable options".
- 4.10 These may have included the original reorganisation application, or it may have reflected alternatives proposed by other people, or options that the Commission may have identified for itself. By law, the reasonably practicable options must also include current local government arrangements i.e. no change.
- 4.11 These options must meet certain legislative criteria before they can be considered "reasonably practicable". To be a "reasonably practicable option", the Commission must be satisfied that:
 - a new or changed council will have the resources to carry out its responsibilities effectively
 - a new or changed district or region will be appropriate for the efficient performance of the local authority's responsibilities
 - a new or changed district or region will contain distinct communities of interest
 - flooding and water management issues will be able to be effectively dealt with (if the option includes the regional council's role).
- 4.12 The Commission then identified its "preferred option". In addition to meeting requirements for "reasonably practicable options", the Commission had to take into account the following further matters:
 - which option will best promote "good local government" which includes:
 - enabling democratic local decision-making
 - providing good quality infrastructure, services and regulatory performance
 - which option will facilitate improved economic performance which may include:
 - efficiencies and cost savings
 - productivity improvements
 - simplified planning processes.
- 4.13 As the Commission's preferred option was not the "no change" option, it proceeded to prepare a *Consultation Document*. A period of community consultation takes place including a period in which the Commission is seeking feedback / submissions on the Consultation Document.
- 4.14 A hearing of the submissions has been provisionally scheduled for late April 2021.
- 4.15 The Commission will then consider whether to proceed to issue a final reorganisation proposal. If the Commission were to decide on the "no change" option, it would end its process there.

Late April 2021	Hearing of submissions – date to be confirmed
Mid May 2021	Outcome expected

5. Discussion

A version 1 draft submission was distributed to Council seeking comments / feedback.

Taking Council's comments and feedback into account, a version 2 draft submission for consideration will be distributed to Council and uploaded to Council's website on or before Tuesday 30 March 2021.

Should the decision be not to proceed with the boundary alteration, the process will end there.

Should the decision be made to proceed with the boundary alteration, The Commission will notify affected parties of the process and timeframe for the change.
