6.1 Adoption of Annual Report for the year ended 30 June 2019

Purpose

To adopt the Annual Report for the year ended 30 June 2019.

MOVED by Cr Tukapua, seconded Cr Mitchell:

THAT Report 19/414 Adoption of Annual Report for the year ended 30 June 2019 be received.

THAT this decision is recognised as significant in terms of s76 of the Local Government Act.

Mrs Debbie Perera of Audit New Zealand joined the table to speak to the Annual Report's adoption. She advised that she was in a position to issue an unmodified opinion which meant that the accounts fairly reflected Council's reported position, both financial and non-financial; however there were a number of requirements included in her opinion that Council would need to address.

Responding to a query as to whether or not it was desirable for a newly elected Council to be adopting the Annual Report, Mrs Perera said it was not irregular or unusual and there were a number of Councils currently in the same position (adopting their Annual Report today) as the procedural deadline for adoption was 31 October and that did not always fit in with elections.

With regard to the adoption of the report, Cr Jennings (as a new councillor) explained why he was prepared to support the report's adoption, with Cr Ketu explaining why he would be abstaining.

Mayor Wanden thanked Mrs Perera for her attendance at today's meeting and, as it may be her last audit for Council, he thanked her also for her efforts over the past 5-6 years which had seen a strengthening in the relationship between Audit and Council.

THAT the Annual Report for the year ended 30 June 2019 be adopted as amended.

THAT the Chief Executive be delegated the authority to make minor grammatical changes to give effect to any outstanding audit recommendations in the publishing of the Annual Report.
