- (i) The Local Government Official Information and Meetings Act 1987
- (ii) The Privacy Act 1993
- (iii) The Local Authorities (Members Interest) Act 1968
- (iv) Sections 99, 105 and 105A of the Crimes Act 1961
- (v) The Secret Commissions Act 1910
- (vi) The Financial Markets Conduct Act 2013
- (vii) Health & Safety at Work Act 2015
- (viii) Public Records Act 2005

Each Councillor is independently and directly responsible for understanding and complying with the requirements of each Act, with Councillor Bishop having been provided with a summary of the scope and application of each of the Acts.
