5.1 Community Wellbeing Network Report

File No.: 23/196

1. Purpose

To give an update and overview on the current Community Wellbeing network committees' activities and actions.

2. Recommendation

- 2.1 That Report 23/196 Community Wellbeing Network Report be received.
- 2.2 That this matter or decision be recognised as not significant in terms of s76 of the Local Government Act 2002.

3. Our Communities

Education Horowhenua

This network met in February 2023 with the Ministry of Education presenting on attendance, stand-downs and early school leaver data. The Horowhenua statistics indicated a high level of truancy and significant number of early school leavers compared to other catchments in the Wellington region. These results were discussed at this meeting prompting the formation of two local working groups – Attendance (at school) and Transitions (beyond school) – to develop solutions that will encompass an all of community approach.

Horowhenua Older Persons' Network

The first Older Persons' meeting was held on 16 February 2023 with 19 community service organisations in attendance.

The two presentations received:

Levin Foodbank

Chairperson Bill Davey provided an overview of the Foodbank and its services. There has been a significant increase in requests for food parcels, not only from the Levin Foodbank, but from all local organisations working in the food support sector. Bill informed the forum about the support they could provide for members.

Neighbourhood Support

Deborah Campbell provided an overview of Neighbourhood Support and the benefits of joining as a member. There has been several reports by forum members about door to door scam activity occurring in the Horowhenua over the summer. In response, Deborah gave some pointers to the forum about how to keep themselves safe at home and in the community.

Key Actions:

- A number of the network members have requested support to profile their
 organisations, promoting their services to the wider Horowhenua community. In
 response to this, the agenda format has undergone a refresh, to allow two 'spotlight'
 slots to be made available for member organisations, so they can schedule a slot to
 talk about their organisation and services. Forum members can also request spotlights
 from organisations outside of the Older Persons' Network membership also.
- The 'spotlight' is an opportunity to overview what they do, share some of the issues
 they are facing and request any support from the network. This also provides network
 members more detailed information about a particular service and a chance to ask any
 questions. The intention is that the member organisation then shares the information



with their clients and communities. This kind of networking and collaboration can be beneficial for everyone involved, building stronger connections and support within the community.

Youth Empowerment Project (yEP)

- Council has changed the approach for yEP 2023 to increase reach and connect with more Horowhenua rangatahi. Rather than a formal or fixed approach, anyone can be involved and members' commitment to the group can be more flexible. This means rangatahi can choose to be involved in yEP in a variety different ways, whether that is showing up and supporting local youth events, attending hui or presenting at Council meetings as a voice for rangatahi.
- During February and March 2023 recruiting for new yEP members began. At the time
 of writing this report, 35 young people have shown interest in being part of this larger
 group. From this a smaller core group will be established as yEP representatives with
 key responsibilities and commitments.
- Council Officers visited Waiopehu, Horowhenua and Manawatū colleges, meeting with principals to talk about the new approach and seeking their support to recruit more young people to join yEP. Engagement with rangatahi has also occurred via speaking at assemblies, videos, newsletters, emails and sign-up events. The Youth Space held a 'Pizza Night' recruitment and promotion event on Friday 17 March 2023 which attracted approximately 35 young people. From this event, ten rangatahi signed up to yEP. The Youth Space Programme Assistant is the coordinator for yEP, therefore strengthening the connection between yEP and The Youth Space.
- The yEP network will hold another recruitment and promotion event on Friday 31 March 2023. Those yEP members who have expressed an interest will have their first official hui on Wednesday 05 April 2023 at The Youth Space where their roles, responsibilities and meeting schedules will be decided. It is at this point that a further update will be provided and an opportunity arranged for yEP to meet the Mayor, Councillors and Community Wellbeing Committee.
- Preparation and planning for Youth Week (15 -21 May 2023) is underway to provide a Parliament trip opportunity for young people who may be interested. We are also looking into secure 'I am HOPE' with Mike King and Nathan Mikaere-Wallis for capacity building events for our young people; and will be open also for parents, teachers, youth workers in our region.
- yEP will become a youth-led group, supported by The Youth Space and Council.

Horowhenua Youth Services Network

The first meeting was held in February 2023 with 14 attendees representing 11 local organisations. This meeting had a workshop to identify key priorities and to build actions based on "How we can work collectively to meet our priorities".

Key priorities from the workshop:

- Connecting people to services, training, jobs
- Capacity building
- · Organisational promotion and profiling
- Anxiety, going back to school and even higher anxiety leaving home
- Cost of living, meeting basic needs
- · Youth housing
- Vaping crisis
- Needs data, statistics



More resources needed

The next meeting is scheduled for Thursday 23 March 2023, with further discussions about how the network will undertake collective actions that relate to the key priorities.

Horowhenua Access and Inclusion Forum

The first meeting was held in February 2023 with 11 attendees that included community services organisations and individuals advocating for people living with disabilities.

Two presentations received:

Literacy Aotearoa

Manager, Piri Robinson, overviewed the Literacy Aotearoa service, in particular the accessible learning arrangements that can be offered to individuals and groups of people with disabilities.

• Horowhenua Health Locality Plans

Project Manager for Horowhenua Locality Prototype, Dr. Yumiko Oliver, outlined locality plans and more specifically work being undertaken in each locality in conjunction with local advisory groups and Iwi Māori Partnership Boards.

Locality plans will be used as a tool to monitor progress on how well local health and social services are meeting local needs. Our Horowhenua plan is co-iwi led (Muaūpoko Tribal Authority and Raukawa Whānau Ora) and Dr. Yumiko is currently in the process of gathering community perspective to inform the development of the Horowhenua Locality Plan.

Five key questions about community aspirations for health and wellbeing services were presented to the forum. The forum suggested that these questions be circulated in survey format for further consideration and revisited at the March meeting.

Key Actions:

- 1. Over the second half of 2022 the forum had a number of discussions about people with mobility challenges being unable to access outdoor natural environments and the detrimental effect this has on wellbeing. The forum highlighted the significant positive health and social impacts for disabled people if all-terrain wheelchairs and walkers were available in the Horowhenua. A proposal has been submitted, by Council on behalf of the Access and Inclusion Forum, to the Department of Internal Affairs for \$25,000 to secure four all-terrain wheelchairs with beach-going capability and two all-terrain walkers.
- 2. The Horowhenua Breathe Easy group requested assistance with grants and funding. Council Officers have sent a meeting invite to discuss funding support required.
- 3. A survey with the Locality Plan questions to be circulated to the forum. Jo Mason and Norelle Ward will meet with Dr. Yumiko Oliver to have a discussion before the next forum meeting.



- The information presented is not targeting anyone. It is a snapshot of Education in the Horowhenua.
- o An attendance rate of 90% or more is considered regular attendance.
- Terms 1 3 2022, 33% of Students in the Horowhenua attended School regularly.
- o 28% for 1 6 year old students.
- o Under 40% for 1-8 (full primary) students.
- o 34% for Immediate Students.
- o 31% for Secondary Students.
- o 352 Stand downs 139 female, 213 male.
- o Average suspension is 30 days.
- o Our district has the highest number of stand-downs in the Wider Wellington and Wairarapa region.
- Māori feature prevalently in low attendance and stand-downs. Many of them prioritise family, sport, cultural events over school. Barriers include physical, mental health and bullying.

• Patrick Rennell:

- Education is not just about schools, it includes childhood education, it's when
 15.5 year olds leave school and go into employment.
- o What can we do to support the work that has been done through Kahui Ako, MOE and Principals themselves?
- Education Horowhenua feeds into the overarching Community Wellbeing Committee, which Grant and Patrick are representatives and we can feed into that group.
- The Attendance data was sobering. It is not a Schools' problem. It is a wider community one.

• Moira Campbell:

The Horowhenua is fortunate enough to have fantastic Whānau ora Navigators working with youth and supporting whanau before they get to the exclusion stage. We are also lucky enough to have great Iwi Partners and relationships and how frustrating it is that they are under resourced.

• Grant Congdon:

o This is a safe place for us to talk, without pointing any fingers and without judgement. There is no point in us coming together and not being able to have robust and open conversations as we are working together.

• Patrick Rennell:

- o What are the 2 or 3 key areas we want to focus on over the next 12 months?
- The last great initiative to come out of Education Horowhenua was the Teen Parent Unit. That was quite a few years ago now.







Grant Congdon/Patrick Rennell:

We would like to propose forming two focus groups. One group to look at Attendance and one to address Transition beyond schools. We are looking for member volunteers who might want to be involved in each focus group. Each will meet up separately and will report back each Education Horowhenua Forum Meeting.

3. Action from previous Meeting

A letter of support has been written on behalf of the forum to support funding applications for Devon Easton and the rangatahi Devon provides locally.

4. Presentation - Piri Robinson from Literacy Aotearoa

Literacy Aotearoa has been delivering learning support in Levin for over 40 years. Aotearoa Literacy provides free literacy and numeracy learning for the community. Their Kaupapa is:

- Tino Rangatira People have ownership of their learning
- Manaakitanga Care and respect for the learner.
- Kotahitanga Whanau learning together
- Literacy and Numeracy Understanding concepts
- The programmes are open to people from 18 80 years old. The Well Steps This is living independently, how to make a shopping list, go shopping, cook a meal and general housework skills.
- Programmes are flexible in design and requirement as the focus is on the learner, their individual plans, their goals and the desired outcomes.
- Q. What training is involved to be a tutor? I was a teacher and have experience supporting people with learning difficulties.
- A. All our tutors have NZ Certificate, Level 5, Adult Literacy. We would also consider people with experience and have knowledge with individual planning.
- Q. Is it time limited for participants?
- A. No. It is based on the outcome and then another goal can be set.
- Q. Given your classroom is upstairs, does this create a barrier for some people to attend? A. There is a downstairs room that can be used. At present all students can get up the stairs. We also send a tutor out to learners' environment if accessibility is an issue. We are looking at all opportunities including online courses.
- Q. If offering learning to people out in the community will you wait a few people in wheelchairs or will you see one person in a wheelchair with able bodied people? A. We try and do this if it is viable.

5. Presentation – Dr Yumiko Oliver from Mūaupoko Tribal Authority

Health Localities

Muaūpoko Tribal Authority and Raukawa Whanau Ora are leading the work to create Locality Plan to tailor health care services in the Horowhenua.

One of the priorities is to hear the aspirations and needs of the community on what is important to them pertaining to health and wellbeing. There are 5 key questions that they want to ask networks whanau and groups in the community.

- What are the most key factors of wellbeing for our community?
- What do you think are the 5 main health issues?
- What behaviours negatively effects health?
- What are 3 or more positives that keeps our community healthy?





• If you could create a system for yourself, what would it look like?

Q. There are locality plans that were done 3 years ago, will some of that still be relevant? Are you drawing on historical information?

A. Wayne Kiriona from Ngāti Raukawa is pulling that information together. We know that some voices were not well elevated, and we want to investigate that. We are looking at using tik tok to ask 'What challenges they face and what can we do in the Horowhenua?

- Jo Mason and Yumiko Olliver will make a time to meet to discuss other ideas.
- Mana Whaikaha has 2023 statistics which shows 569 people living with disabilities in the Horowhenua. They also have a collective database of clubs etc that they are happy to share.
- Yumiko is interested in discussing this further with Norelle.
- Q. Kate has noticed that members of the community have a sense that things should be provided for them instead of them engaging in areas of interest. There is also competition between agencies instead of working together.
- A. This is an issue. The idea is that you will get wrap around support to ensure wellbeing.
- Q. At Literacy Aotearoa, there is a group of neuro diverse people which you could come and have a discussion with. They are looking at ways to look after themselves, so it would be great to have them involved in the process.
- A. Invitation accepted.
- Q. Will you cover advocacy? Sometimes the barrier is the family. Finding an advocate is hard and sometimes the family will not agree to have this support.

 A. Yes we support advocacy
- Cr. Tukapua invited Yumiko to attend the Horowhenua Services Network. This Network group has already recognised vaping as an issue.

3. General Business – Round the Table

Derek Prior – Riding for the Disabled

The group has a new venue off Makomako Road. The arena has been built and is now operational. Special thanks to Jeff Kane, HDC, Rotary and Volunteers. Due to needing replacement coaches, RDA will be opening on Wednesday and Thursday 9am – 11.30am. There will be four blocks of ½ hour lessons with four riders in each block. We are looking for volunteers that can help on Saturdays.

Tracey Scott - Age Concern

- Tracey is newly appointed to Age Concern as a Disability Navigator. There is an 'Aging Well Course' that runs from 10am 2pm, which is specifically designed for people feeling socially disconnected and has a maximum group size of 10. The course runs for 10 consecutive Fridays and following by becoming a regular coffee group. We intend to run these courses back-to-back.
- The organisation has a 'Beyond Disability Fund' which is for people wanting to improve their lives in the community. They can purchase resources and equipment to live independently. The fund is from MSD (Ministry of Social Development) and the funding is available until June.

Daphne Barret - Horowhenua Breathe Easy





 Would like to provide educational programmes for 2023, giving advice to people with respiratory conditions. Kim suggested that the group might like to apply for a HDC grant to help pay for the speakers.

Sharon Smith – Community Connections

 Community Connections are looking for staff that will support their clients to access the community. They will train anyone that is interested.

Scott Richards - CCS Disability Action

• CCS Disability Action is growing in the Horowhenua. Aleesha is the access contractor and supports places to improve access. She does Adult Safeguarding and is open to referrals.

Kate Aplin - Volunteer Central

- The challenge that they are facing is organisations that are not prepared to have people with disabilities as volunteers. The question now is: How can we prepare the community to have people with disabilities? Volunteer Central will look at this to find a way to address it with the community.
- The Volunteer Recognition celebration is in June, with nominations opening in a couple of months.. Volunteer Central are offering 3 workshops to build organisation capacity to recruit and retain volunteers. This workshop will be held at Te Takeretanga o Kura hau-pō, 9 11am:
 - 1. 22 March Developing Positive Volunteering Culture
 - 2. 26 April Volunteer Recruitment and Role Development
 - 3. 24 May -Volunteer Retention and Recognition

Norelle Ward - Mana Whaikaha

- Supporting connectors that works with whanau to grow capacity and skills required to support individuals or groups.
- Working to encourage landlords to accept people living with disabilities as tenants.

They help people with:

- Connecting people to services and other people in the community
- Civil defence preparedness support
- Neighbourhood disputes
- DC is on the local welfare committee.
- Regular email newsletter updates about local events and activities. Notifications about local scams and criminal activity.

It is FREE to sign up. Send Deborah an email <u>info@horowhenuansg.org.nz</u> if you would like to join. When you sign up you receive a Neighbourhood Support Pack and Civil Defence information.

Keeping Safe in your Home/out in the Community:

- If someone comes to your door and you don't know them. Engage with them through a Screen door or a window.
- You can ask for ID
- If you receive a text notifying you about a parcel that you are not expecting. Delete
 the message and block the number.
- If you live alone, place Gumboots outside to give the idea that there is another person living on site.
- Be aware that there are people going around door knocking and offering services.
 They are taking money up front and not coming back to finish off the work.
- Keep Garage Doors closed, especially if you have internal access.
- Keep a phone by your bed.
- Don't carry around large amounts of cash or leave valuables sitting in plain in sight of your car.
- If you need to evacuate, ensure you have a plan and a Getaway pack that is ready to go.
- Scams are an ongoing problem. People take advantage of the vulnerable. Older people are very susceptible as they are trusting, accommodating and they like to help. So they are often targeted.
- If you have a medical alarm. You will not get in trouble if you press the button if you
 have a prowler. Please do not hesitate to press it if needed

Mayor Bernie Wanden

- National decrease of housing needs
- National decrease of those needing support.





Housing discussion points:

- Marion Fulljames Clients are struggling to find rentals. More than 50% are single people requiring accommodation. MSN can help with Accommodation Supplement support.
- Susan Carson: If Clients need age care they are sent to palmy until there is space is available here.
- Kate Jenkins: Any plans for Retirement Homes?
- Mayor Bernie: We have one of the highest population of older people. We won't be building, but we certainly encourage others/developers to do so. Some of our rest homes have bare land and have plans to expand in the future. Some questions for the forum to consider:
 - Do I need to get those working in that space to get together and have a discussion about beds and capacity?
 - o Who should we be talking to?
 - o Who should we be advocating to?
- Neil Walton: Rates rebates now available. Takes 5 minutes to do it.

Water Restrictions discussion points:

- The community are notified about Water Restrictions via the Council Website, Social Media and the Community Newspaper.
- Water Meters are also used as Leak Detectors. We lose 25% of water before it gets to households.
- Connectivity is an increasing problem for older people, so they often are not aware of restrictions.
- Robyn Pescini said it is also our role to let clients/members of our own organisations
- Could we pop posters up in areas that are heavily frequented by older people, such as Te Whare Mahana, Supermarkets, Library, Cossie Club etc?

5.2 Community Wellbeing Committee

File No.: 23/213

1. Purpose

To outline the objectives and priorities of the Community Wellbeing Committee for the 2022 triennium and collectively input into the way in which the Committee functions to ensure that the Committee is delivering meaningful outcomes for the community.

2. Recommendation

- 2.1 That Report 23/213 Community Wellbeing Committee be received.
- 2.2 That this matter or decision be recognised as not significant in terms of s76 of the Local Government Act 2002.

3. Background/Previous Council Decisions

- 3.1 The Community Wellbeing Committee is a committee of Horowhenua District Council that involves representatives from Council, government and non-government organisations, as well as community forums. The Committee's primary objective is to achieve population-level results and indicators, as well as key action plans, to promote the wellbeing of the community. Rather than focusing on specific programme deliverables or client-level results, the Committee takes a broader view to achieve greater impact.
- 3.2 The Terms of Reference state that the Community Wellbeing Committee will have the responsibility to:
 - Oversee the implementation of the Community Wellbeing Strategy and associated wellbeing action plans
 - Determine the key population level results and indicators for the next 3 years, and monitor those
 - Receive reports from the Community Development Team that summarise target population group activity by Council and Council working groups
 - Receive six monthly reports from all member agencies regarding activity directed at target population groups and provision of data that relates to specified strategy indicators
 - Actively encourage coordination of members and their activities
 - Foster strategic collaborations and partnerships
 - Provide advice to Council Officers on matters of community wellbeing in relation to specific target populations
 - Seek to collectively influence relevant public policy
 - Communicate Committee activity and information to the public
 - Educate the public and community on wellbeing matters
 - Actively seek individual agency performance improvement, as well as "community wide" improvement
 - Encourage community based local solutions to local issues
 - Keep the wider community updated on progress towards the results sought across the Horowhenua District.
- 3.3 The Community Wellbeing Committee oversees five network committees that report into the Community Wellbeing Committee. These committees include the Youth Empowerment Project (yEP), Youth Services Network, Older Persons' Network, Access and Inclusion, and Education Horowhenua.

Each committee is composed of community organisations and members who work collaboratively towards common goals related to their specific areas of focus. For instance,



the yEP and Youth Services Network aim to empower young people by providing them with the resources and support they need to thrive. The Older Persons Network focuses on the needs of seniors, while the Access and Inclusion committee is committed to promoting inclusivity and diversity in the community. Lastly, the Education Horowhenua committee aims to enhance educational outcomes and opportunities for students.

The five network committees play a critical role in improving community wellbeing. By collaborating with various organisations and agencies, these committees identify key issues affecting the community and develop targeted solutions to address them. They provide a platform for information sharing, resource allocation, and develop action plans to address that contribute to work plans. They are represented on the Community Wellbeing Committee and escalate complex or significant issues to the Community Wellbeing Committee for wider input and collaboration. By working together, these committees are able to maximize the impact of their initiatives and promote positive outcomes for the Horowhenua community.

4. Issues for Consideration

- The Community Wellbeing function is a critical component that spans across all Council departments, community organisations, and the wider community. Recognising the importance of this kaupapa, the Council is undertaking a reset to better reflect its significance. Previously, the Community Development Team was responsible for the community wellbeing function, and while they continue to have an important role to play, the Council is resetting expectations internally to achieve greater outcomes for the community. This reset aims to ensure that all departments across Council are aligned towards the common goal of improving community wellbeing, resulting in more effective and efficient solutions to complex community issues. Through this approach, the Council hopes to achieve meaningful outcomes for the community and create a more inclusive and prosperous society.
- Council have received feedback that the Community Wellbeing Committee has been a forum where a lot of reports and presentations have been delivered, however robust conversations and the development of actions for collective action have been limited. While these reports have been informative and interesting and related to community wellbeing, Council wants to ensure that the Committee is more meaningful and seen to be making a difference within the community. To address this, Council are planning to reset its approach and focus on developing actionable solutions and strategies to improve community wellbeing. This will involve more engagement with community organisations, the wider community, and Council departments to identify key priorities and develop targeted action plans. By prioritising action and collaboration, the Committee hopes to make a meaningful impact on community wellbeing and achieve tangible outcomes that benefit the Horowhenua community.
- The Community Wellbeing Strategy, also known as the Stronger Communities Strategy, outlines crucial priorities and measures concerning community wellbeing. The key purpose of the Community Wellbeing Strategy and therefore the Community Wellbeing Committee is to provide collective leadership, advocacy and holistic outcomes that enable the population of Horowhenua to be well together.
- The Community Wellbeing Committee set the following priorities at the first meeting of the previous triennium (11 February 2020).
 - **Housing** The Community Wellbeing Committee will collectively work together toward making Horowhenua a place where everyone has access to enough resources, including housing, to participate fully in their community and everyone has the chance to flourish.
 - **Growth** Alongside Council, the Community Wellbeing Committee must demonstrate leadership on growth management on behalf of the community. To ensure that; the social cohesion and cultural diversity of our communities are strengthened; the quality of



health, education and social services is maintained and improved; the community feels safe; the economy is sustained and encouraged to thrive, and no one person is left behind.

Health and Wellbeing - To improve the health and wellbeing of all Horowhenua people, the Community Wellbeing Committee must work together to remove barriers, eliminate discrimination and disadvantage and provide meaningful opportunities and choices for all.

Community Belonging - The Community Wellbeing Committee will work toward enhancing and celebrating the strength, diversity and vibrancy of Horowhenua to allow people to feel a sense of belonging, inclusion and social connectedness. As a result, our people have a sense of pride.

Community Safety - To improve health and wellbeing, we must address inequity, exclusion and disadvantage experienced by individuals, whānau and communities. This includes ensuring that children and young people are given the opportunity to reach their potential so that they do not experience disadvantage as adults.

 By redefining the way in which the Committee operates and prioritising the actions outlined in the Community Wellbeing Strategy, we are confident that we can attain more favourable results for the community when the Strategy and Action Plan undergo review in 2024.
