6.1 Chairperson's Report

File No.: 23/411

1. Purpose

To receive the Chairperson's report highlighting matters of interest to the Te Awahou Foxton Community Board

2. Recommendation

- 2.1 That Report 23/411 Chairperson's Report be received.
- 2.2 That this matter or decision be recognised as not significant in terms of s76 of the Local Government Act 2002.

3. Matters of Interest

- 3.1 Here we are halfway through 2023, enjoying a warmer than usual autumn. We should enjoy it while we can bearing in mind that global warming is here and happening. If we want a pleasant and prosperous world for our whanau we need to do something about it before it is too late. Each and every one of us can help ourselves and each other by reducing our use of non-recyclable plastics, composting our food waste and walking, not driving when the distances are small.
- 3.2 We have an interesting and busy TAFCB Meeting in June;
- 3.3 First we express our thanks to HDC for their prompt installation of Deer Warning signs on Palmer Road, Foxton Beach. This happened with the least fuss I have ever seen. Thanks HDC.

Waka Kotahi

3.4 Waka Kotahi are also going to speak with us about the up-coming O2NL highway and the anticipated effects on Foxton and Foxton Beach. Hopefully it will be an opportunity to discuss other matters of concern, such as the entrance and exit from Main Street, Foxton possibly with roundabouts; Signage on SH1 for Foxton attractions such as De Molen, Mav Tech, Wildlife Foxton, Te Awahou Nieuwe Stroom, Foxton Beach and the internationally recognised Ramsar site. We also may be able to mention the surface break up at the corner of Johnstone and Union Streets.

Foxton Rugby Club

- 3.5 We have a presentation from The Foxton Rugby Club, an important part of our community. Their documentation has been provided to the Democracy team for TAFCB seeking our support. Horowhenua District Council Meeting
- 3.6 On 31st May was important as there were deliberations on the matters we submitted on regarding the LTP. Full details of the outcomes are available on the HDC Website. However here is a brief review:
- 3.7 Rates review. It was voted 6-7 to retain the existing system.
- 3.8 Levin landfill Option 2, which the Board supported was supported.
- 3.9 Key Water Infrastructure We supported option 1, to increase the budget to deliver the projects we need was also carried.
- 3.10 Foxton Beach Freeholding Account: The Council approved \$500,000 from the fund for the Foxton Pool Redevelopment Project. It was noted that this deviation from policy will be

included in the background which informs the policy review. It is worthwhile pointing out that policy is not regulation and can be changed with the appropriate procedures.

- 3.11 In the Activities Report several beneficial items were approved including Item 2.12 that Officers develop a comprehensive and inclusive plan for Target Reserve. The inclusion of various recreational activities including walking, Mountain biking, equestrian activities and existing groups such as the Pistol Club and Horowhenua Paintballing. We as a board should ensure that there is a round table discussion by all groups in the spirit and cooperation, inclusion and where necessary, compromise.
- 3.12 There were no recommendations from Council Officers on Items 14, Topic 11 and 12, the Manawatu Estuary Ramsar Site and the Coastal Sand Dunes. The TAFCB needs to give some attention to these important ecological features of our area. They cannot be neglected. It is noted that the Manawatu Estuary Management group which includes HDC, HRC and DoC are working on this. We need to keep abreast of developments there.

Good evening,

After speaking with Karyn-Maree, about Horizons extending their drainage network through our farm, I have to consider the question – why would we agree to this extension?

There is no evidence to indicate we would be better off. On the contrary all the evidence is we would be worse off. There has been no evidence presented to indicate such an acquisition would be of benefit to the Foxton East drainage scheme, quite the contrary. At our last meeting we outlined our concerns. Nothing that has happened since has alleviated those concerns.

I have used photos, in the attachments, to reinforce my arguments against Horizons taking over our drainage system. The 1st attachment, labelled the condition of the drain, show:

- (1) the drain exiting our farm into the jungle of willow trees
- (2) the drain being restricted in its flow by willow trees
- (3) the drain emerging from the trees
- (4) an extended view of the drain. It is there somewhere

the 2nd attachment contains 2 different sections of the map document prepared by Mr Warren Wheeler in 2006.

(A) shows the path of Kings canal as it exits into the Loop.

(B) shows quite clearly the Foxton East drainage system extends 215 m, from the Norbiton Road corner, along the western edge of the unformed road until it reaches the culvert servicing the water coming from the eastern side of the road. These maps clearly show Spring Street extension is part of the Foxton East drainage system. The part of the drain from east of the culvert and running north along the edge of the unformed road would be the responsibility of Horowhenua District Council. They are probably unaware of that.

The potential to flood Foxton at the Norbiton Road corner.


The urban section of Spring Street from the Norbiton Road corner to where the drain exits on the south side of Avenue Road is piped. The entrance to this piped section has a grated cover stopping debris and small children from entering. Considering the state of the drain upstream the potential for a semi-or total blockage is a real threat to urban Foxton.

I reiterate my concerns. The standard of maintenance of the sections of drain under the Foxton East drainage schemes control is totally inadequate.


I will not go into the \$2.8 million squandered by Horizons in any detail, except to say the original purpose of the whole upgrade was to stop the flooding in Cook Street. I have yet to see anything done to alleviate the flooding.






The above attachment contains a news report of a meeting to discuss the problems of Hokio Stream. It is obvious from this report Horizons freshwater and partnerships manager, Logan Brown, understands water flows freely through gravel but only seeps through sand. This fact is obviously understood by some within Horizons but is not widely understood within the bulk of the Horizons personnel.

Why do I bring this newspaper article to your attention? Because it is still the intention to sheet pile the true right bank of Kings Canal despite there not being any visual evidence of seepage through the bank causing the flooding in Cook Street.

3. Liaison Activity

MAVtech

- 3.1 The chair of MAVtech supported by Cr. Ross Brannigan has met to identify maintenance required to building including repair of leaks threatening to damage collections.
- 3.2 Collections continue to grow each month donations are offered and have to be assessed and sorted through to ensure acquisitions are filling gaps or providing good backups. This workload is carried out by very committed small team of volunteers and trustees.
- 3.3 MAVtech has applied for the final round of Museum Covid funding to increase accessibility of collections through improved lighting and covering power costs as donations and visitor numbers are not yet back up to pre-covid levels.
- 3.4 A new volunteer has stepped up in supporting the Trust as secretary, helping ease the load.
- 3.5 Night movies will stop at the end of June due to colder weather until warmer temperatures return.
- 3.6 New brochures are being finalised to continue the vision of growing awareness of MAVtech.
- 3.7 Next open day is 24th June 1-4.30pm and July 22nd 1-4.30pm.

Foxton Beach Community Centre

- 3.8 The construction of the new garage is making the centre busier than ever. By the time this report is read the FBCC committee will have main build finished and be working on driveway access.
- 3.9 The book sale held at Kings Birthday weekend brought in much need funds for petrol costs rising at the end of June with fuel taxes coming back on. The committee has decided there would be no increase in costs to user, instead channelling their op shop social enterprise efforts helping to cover increased costs.
- 3.10 The FBCC had is AGM last week with most of their committee re-standing, a new Patron appointed and looking forward investigating changes the new Incorporated Society brings so a change to becoming a charitable trust is being investigated.
- 3.11 Covid and flu jabs are expected to stop sometime in June but that could change if there is another resurgence in numbers rat kits and masks still available free.
- 3.12 The committee is looking forward to seeing their request for new wheelchair accessible van grant from the Freeholding account goes through the Council process with ease and speed.

Foxton Beach Progressive Assn Inc

3.9 The Association hosted a meeting at Foxton Beach School on 18 May to support consultation on \$500,000 coming from the Freeholding Account to help fund the Foxton pool redevelopment. There were 73 people in attendance and approximately ³/₄'s gave a vote for taking money from fund despite it causing the Account to go below the policy minimum balance of \$5,000.000.

6.3 **Community Board Member Update - Brett Russell** File No.: 23/416

1. Purpose

To report back on liaison activity with:

- the Horowhenua Community Camera Trust and,
- the Wildlife Foxton Community Trust

2. Recommendation

2.1 That Report 23/416 Community Board Member Update - Brett Russell be received.

3. Liaison Activity

Wildlife Foxton Trust

- 3.1 On As we head into winter, the Trust's visitors during the week drop off but they are still seeing groups out and about on Sundays. It's interesting that the cost-of-living crisis is not affecting visitor numbers (given normal drop in cooler weather) but it is certainly affecting native plant sales.
- 3.2 They have been thrilled to receive a grant from the Foxton Promotions Group (Easter Fair) which enables the fit out another aquarium tank making them another step closer to opening up their planned extension. With the less visitors they can focus more on the container fitout of electrics and lighting getting ready for the day they can fit out tanks and fill them with 5 native fish species for education and advocacy. The Trust would also like to thank HDC Community grants for helping them to provide free photocopying to other not-for-profit groups.
- 3.3 It was also exciting for Trust representatives to be up in Palmerston North on Friday, 9 June to celebrate recognition of Dr. Bob Hoskins' many hours contributing to the environmental health of the Foxton Beach area through Volunteer Central and support of HDC.
- July means school holidays and more visitors from outside the region as well as their next 3.4 Massey Vet student placement onsite for nearly 3 weeks - supporting our future vets to gain experience in native and exotic lizards and fish husbandry.

Manawatu Estruary Trust (MET)

- 3.5 The Trust held its monthly meeting at the Holben Pavilion on Tuesday, 6 June at 7 pm. In addition to administrative items two other items were discussed: first John McCartin updated the trust on his initial discussions with Architect Philip Enfield regarding the proposed second estuary viewing platform proposed for the Sunset Walkway; and second, Wildlife Foxton Trust's Dave Coles gave a presentation about the flora, fauna, fish and birdlife that inhabit the Ramsar site. It was agreed this information would be held on a dedicated laptop computer located at the Wildlife Foxton Trust. It will also be used as a key resource for MET as they get ready to develop their own web site.
- The meeting was also briefed on: 3.6
 - The Manawatu Estuary Management Team workshop scheduled for Friday, 23 June 2023 as part of the process to update and enhance existing plans for the Manawatu Estuary and Ramsar site: and.
 - The Manawatu Estuary Planting Day scheduled for Saturday, 1 July, 10.00 am to 12.00 pm.

The Horowhenua Community Camera Trust (HCCT)

- 3.7 Under the banner 'helping you feel safer', The Trust held it's AGM on Tuesday, Tuesday, 13 June here in the TANS building. It was well attended with Mayor Bernie giving the opening address and with local businesses representatives and community minded citizens and many elected local body representatives and permanent HDC staff members in attendance.
- 3.8 As part of his introductory remarks Trust Chairman Ted Melton commented referred to the roll-out of CCTV cameras at Foxton Beach four years ago, as a ground-breaking initiative of the Foxton Beach Progressive Society Incorporated to help improve community safety and well-being at the beach. It was also instrumental in the formation of the Camera Trust itself. Since then, the Trust has gone from strength-to-strength as it continues to plan, among other things, for the roll out of CCTV cameras in Foxton town and Shannon respectively.
- 3.9 After the formal AGM activities had been completed Michelle Rogers, outgoing Community and Social Development Manager, gave a presentation regarding safer communities which highlighted the following:
 - Enhanced Synergy
 - Increased Social Capital
 - Joint Interagency Work
 - Mapping-Connecting Initiatives
 - Sharing Best Practice
 - Amplified Impact and Reach
 - Collaboration

With further discussion on the How and the Why to follow.

- 3.10 Ted then proposed a sort of SWOT analysis concept to assess community safety down the track. Security was deemed important with Ted confirming all aspects of the Trust's activities were undertaken with full compliance with New Zealand's Privacy legislation. He touched on the potential advantages of a shared community website which illustrated successes about community safety via good stories. This could perhaps be combined with a strong vision about the Horowhenua being a great place to work, live and play in. HDC Chief Executive Monique Davidson then commented on the ongoing need for a strong safety network with inputs from central government, HDC and the volunteer community sector. Such a network could focus on key priority community outcomes and perhaps tackle issues associated with children attending school, shoplifting or similar.
- 3.11 In closing Ted thanked, among others, the Council and Police for their ongoing support. He acknowledged the Trust would need to work more closely with HDC's Community and Wellbeing Committee and other community groups in the future.
