A geese cull was to be undertaken in early April but was cancelled due to health and safety issues. A Hazard Management/Health & Safety Plan was brought to the May 2018 Board meeting and a geese cull is being planned. Poultry numbers at the Domain have been reduced significantly, with poultry being rehomed. HDC approved an amount of up to \$10,000 to develop a Reserve Management Plan in its 2018/2038 LTP subject to negotiation with other stakeholders for joint funding. Board Members would be advised when the geese cull would be progressed.
