## **Response - Official Information Request**

I refer to your request for information received on 5 September 2023. Your request has been considered under the Local Government Official Information and Meetings Act 1987 (LGOIMA) and I provide the following information.

"As part of the treaty claim process for Ngati Raukawa, Te Kenehi Teira, Des Kahotea and I are doing a research project on the protection (or lack of protection) of wahi tapu and wahi tupuna within our tribal rohe, particularly Manawatu and Horowhenua.

While we've looked on the HDC website and seen the Horowhenua District Plan 2015, and Plan Change 1 - historic heritage, decision July 2018, adding further buildings and places to Schedule 2, we would like to know of earlier policies and listings which are also relevant.

When did the HDC first have a policy about protecting historic heritage, what was that policy, and how has that changed over time. Has there ever been a policy of listing Maori heritage places separately? Has there been discussion with hapu or iwi representatives about this?"

## <u>Historic Heritage under the Horowhenua District Plan</u>

The Horowhenua District Plan has included a list of protected heritage buildings and sites, along with supporting rules, objectives, and policies since September 1999. This was the date the first District Plan prepared under the Resource Management Act 1991 became operative (took full legal effect). Additional buildings and sites were added to this list when the District Plan was reviewed in its entirety in 2015 (note: this process commenced in 2013 and was completed in 2015). Further sites were added in 2018 via Plan Change 1.

At present, the District Plan does not list any specific Māori heritage or wahi tapu sites. This was discussed with Iwi and Hapū at the time the District Plan was reviewed in its entirety. At this time, different Iwi groups were at different stages in terms of being able to identify the sites they wanted protected in the District Plan. The Iwi representatives involved determined it most appropriate to wait until all Iwi were in a position identify their sites before listing and protecting such sites in the District Plan, to avoid a situation where some Iwi's sites were protected while others were not.

As part this process, the Iwi representatives involved (from Muaūpoko, Rangitane, Ngati Raukawa, and Ngati Apa) jointly prepared Chapter 1 'Matters of Importance to Tāngata Whenua' of the Horowhenua District Plan, which includes a statement from each Iwi, and objectives and policies



covering a range of matters deemed significant by Iwi. This chapter expresses the intention of both the Council and the 4 Iwi involved to continue working towards ensuring appropriate protection of sites of cultural significance, wāhi tapu, wāhi, tūpuna and other taonga.

Also, as a supplementary question, has the HDC received any documents about wahi tapu and wahi tupuna from Ngati Raukawa - either from the Runanga or any whanau or hapu representatives?"

Council has not received a finalised list of wahi tapu and wahi tupuna from Ngati Raukawa. Council has received documents such as Cultural Impact Assessments about particular projects which may include details on sites and has also received a draft Environmental Iwi Management Plan which includes information about cultural sites and was provided to Council for informational purposes. However, as far we understand this document has not been finalised.
